The Faculty Senate voted to approve the following change in section 4.213.2, page 36 of the University Manual relative to membership on the Advisory Committee on University Policy (changes underlined):

4.213.2 Membership. This committee shall consist of the President of the University, Chairman; the Executive Committee of the current Faculty Senate; the Chairman and Vice Chairman of the immediately past Faculty Senate (if either or both are unable to serve, replacements will be chosen from the immediately past Executive Committee by the Chairman of that committee); the Deans of the Colleges and schools and any other faculty members or officers of the University the President may name, not exceeding three in number.
