ESTABLISHMENT OF A DEPARTMENT OF COMPUTER SCIENCE

The Faculty Senate approved the establishment of a Department of Computer Science in the College of Arts and Sciences. In addition, the Senate approved the following statement regarding the Department of Computer Science, "Emphasize the importance of the independence of the Computer Laboratory from the Department of Computer Science, the former as a service agency to the entire campus community, the latter as an independent academic department."
