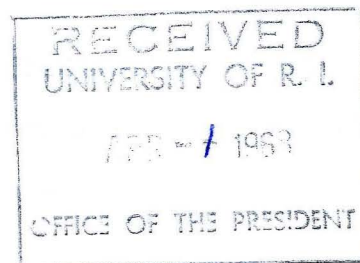

BILL #203

Recommendations:

1. That the course number 300 (and 301, in a few special cases where a two-semester sequence of instruction is desirable) be used for courses limited to graduate student enrollment, which might or might not carry "registration" credit, but which do not carry "program" credit toward a degree.
2. That the catalog descriptions of such courses specify the credit restrictions.
3. That the present Manual, (p. 61), Catalog (p. 122), and the Graduate School Statement of Policies (p. 6) descriptions of the course-numbering system be modified accordingly.
4. That a statement be included in the catalog description of the course-numbering system to indicate the expectation that the level of instruction will correlate the clientele.
