5.77.12 The committee shall comprise the President as chairman; the executive committee of the Faculty Senate; the chairman and vice chairman of the immediately past Faculty Senate (if either or both are unable to serve, replacements shall be chosen from the immediately past executive committee by the chairman of that committee); the deans of the colleges and schools, the President of the Administrative Staff Association (or his designated representative) and any other faculty members or officers of the University the President may name, not exceeding three in number.
