FACULTY SENATE

On September 9, 1982, the Faculty Senate voted to approve the following amendments to sections 5.13.12 and 5.14.13 of the University Manual recommended by the Executive Committee:

5.13.12 The Senate's representatives on the Development Council shall report to the Faculty Senate at least once each year and at any time there is a major change in policy. They shall keep the Senate informed of policies in effect.

5.14.13 The faculty representatives on the Athletics Advisory Board shall report to the Faculty Senate at least once each year and whenever there is a major change in policy. They shall keep the Senate informed of policies in effect.
