Mr. FULBRIGHT (for himself, Mr. JACKSON, and Mr. SCOTT of Pennsylvania) introduced the following bill; which was read twice and referred to the Committee on Rules and Administration

A BILL

To authorize the Smithsonian Institution to plan museum support facilities.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 That the Regents of the Smithsonian Institution are au-
4 thorized to prepare plans for museum support facilities for
5 the care, curation, conservation, deposit, preparation, and
6 study of the national collections of scientific and historical
7 and artistic objects, specimens, and artifacts, and for the
8 related documentation of such collections of the Smithsonian
9 Institution.

10 SEC. 2. The museum support facilities referred to in

1 section 1 shall be located on federally owned land within the
2 metropolitan area of the District of Columbia. Any Federal
3 agency is authorized to transfer land under its jurisdiction
4 to the Smithsonian Institution for such purposes without
5 reimbursement.

6 SEC. 3. There are hereby authorized to be appropriated
7 to the Smithsonian Institution such sums as may be nec-
8 . essary to accomplish the purposes of this Act,
