
## MEMORANDUM

RE: NATIONAL GALLERY EXHIBIT FOR RHODE ISLAND




Today I had lunch with Dr. Evans at the National Gallery, and afterwards we selected reproductions of 16 paintings by Italian masters. He asked that I assist him at some future date in picking out suitable frames although the choice is rather limited. He estimates roughly that the show should be prepared and boxed by about mid-May. On each frame there will be an identifying label and then there would be some separate mimeographed sheets with more descriptive material. He has asked that I work with him on this, especially as he presumes we would like to include a few words from you or about you. I assured him that for our part the Providence office would schedule the show. He suggested that the suitable length of time for this show in any one place would) probably be about three weeks so it might be easiest to schedule it to arrive at each new place on the first of the month. Isabelle Leeds will approach equivalent) institutions, probably libraries, in about 20 towns to see if they are interested. In the towns where thay are not interested she will then look around to see what else might like to have the show.
