**Amendment To H.R. 2351, As Reported
Offered by Mr. Gunderson of Wisconsin
and Mrs. Slaughter of New York**

Page 2, after line 6, insert the following:

1 (a) MODIFICATION OF LIMITATION ON USE OF FED-
2 ERAL FUNDS.—Section 5(g) of the National Foundation
3 on the Arts and the Humanities Act of 1965 (20 U.S.C.
4 954(g)) is amended—

5 (1) in paragraph (4)(C)—

6 (A) by inserting “(i)” after “(C)”, and

7 (B) by adding at the end the following:

8 “(ii) Notwithstanding any other provision of this sub-
9 section, the amount allotted to a State for the current fis-
10 cal year under this subsection may not be greater than
11 the amount so allotted to such State for the preceding fis-
12 cal year if—

13 “(I) the amount of State funds to be expended
14 for such current fiscal year to carry out this sub-
15 section is less than the average annual amount ex-
16 pended by such State during the most recent preced-
17 ing period of 3 fiscal years to carry out this sub-
18 section; and

19 “(II) the rate of the reduction in the amount of
20 State funds exceeds the rate of reduction in the ag-

1 gregate of all general fund expenditures to be made
 2 by the State in such current fiscal year.”, and
 3 (2) in paragraph (5)—
 4 (A) by striking “(5) All” and inserting
 5 “(5)(A) Except as provided in subparagraph
 6 (B), all”, and
 7 (B) by adding at the end the following:
 8 “(B) All amounts allotted under paragraph (3) that
 9 are not made available to a State as a result of the oper-
 10 ation of subsection (g)(4)(C)(ii) shall be allotted to the
 11 remaining States in equal amounts.”.

Page 2, line 7, strike “(a)” and insert “(b)”.

Page 3, line 8, strike “(b)” and insert “(c)”.

Page 4, line 24, strike “(c)” and insert “(d)”.

Page 5, line 11 strike “(d)” and insert “(e)”.

Page 5, after line 22, insert the following:

12 (f) INVESTIGATION AND REPORT.—Not later than
 13 September 30, 1995, the Chairperson of the National En-
 14 dowment for the Arts shall—

1 (1) conduct an investigation of State compli-
2 ance with section 5(g)(4)(C)(i) of the National
3 Foundation on the Arts and the Humanities Act of

5 (2) submit to the Speaker of the House of Rep-
6 resentatives and the President pro tempore, a report
7 containing—

8 (A) the results of such investigation, and

9 (B) any information and recommendations
10 as the Chairperson considers to be appropriate.
