# AN ACT

To amend and extend the National Foundation on the Arts and Humanities Act of 1965, to provide for the improvement of museum services, to establish a challenge grant program, and for other purposes.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 That this Act may be cited as the "Arts, Humanities, and
- 4 Cultural Affairs Act of 1976".

## TITLE I—ARTS AND HUMANITIES

- 6 STATE HUMANITIES COUNCILS
- 7 Sec. 101. (a) Section 7 of the National Foundation on
- 8 the Arts and the Humanities Act of 1965 is amended by
- 9 adding at the end thereof the following new subsection:

1	"(f) (1) The Chairman, with the advice of the Na-
2	tional Council on the Humanities, is authorized to establish
3	and carry out programs of grants-in-aid in each of the sev-
4	eral States in order to support not more than 50 per centum
5	of the cost of existing activities which meet the standards
6	enumerated in subsection (c), and in order to develop pro-
7	grams in the humanities in such a manner as will furnish
8	adequate programs in the humanities in each of the several
9	States.
10	"(2) In order to receive assistance under this subsec-
11	tion in any fiscal year, any person or entity desiring to
12	receive such assistance shall submit an application for such
13	grants at such time as shall be specified by the Chairman
14	and accompany such applications with a plan which the
15	Chairman finds—
16	"(A) provides that funds paid to the grant recip-
<b>17</b>	ient will be expended solely on programs which carry
18	out the objectives of subsection (c);
19	"(B) establishes a membership policy which is de-
20	signed to assure broad public representation with respect
21	to programs administered by such grant recipient;
<b>22</b>	"(C) provides a nomination process which assures
23	an opportunity for nomination to membership from var-
24	ious groups within the State involved;

1 (D) provides for the rotation of the membership
2 and officers of such grant recipient on a regular basis;
3 "(E) establishes reporting procedures which are
designed to inform the chief executive officer of the State
5 involved, and other appropriate officers and agencies, of
6 the activities of such grant recipient;
"(F) establishes procedures to assure public access
8 to information relating to such activities;
9 "(G) provides that such grant recipient shall make
reports to the Chairman from time to time, in such form
and containing such information as the Chairman may
require; and
"(H) provides that two members of the executive
body of such grant recipient shall be appointed by an
appropriate officer or agency of the State involved.
"(3) Of the sums available to carry out this subsection
17 for any fiscal year, each grant recipient which has a plan
approved by the Chairman shall be allotted at least \$200,-
19 000. If the sums appropriated are insufficient to make the
20 allotments under the preceding sentence in full, such sums
shall be allotted among such grant recipients in equal
22 amounts. In any case where the sums available to carry out
this subsection for any fiscal year are in excess of the amount

- 1 required to make the allotments under the first sentence of
- 2 this paragraph—
- 3 "(A) the amount of such excess which is no greater
- 4 than 25 per centum of the sums available to carry out
- 5 this subsection for any fiscal year shall be available to

- 8 "(B) the amount of such excess, if any, which re-
- 9 mains after reserving in full for the Chairman the

- "(A) a grant recipient is not complying substan-

- 9 "(B) a grant recipient is not complying substan-
- tially with terms and conditions of its plan approved under
- this subsection; or
- "(C) any funds granted to any person or entity under
- this subsection have been diverted from the purposes for
- 14 which they are allotted or paid,
- 15 the Chairman shall immediately notify the Secretary of the
- 16 Treasury and the grant recipient with respect to which such
- 17 finding was made that no further grants will be made under
- 18 this subsection to such grant recipient until there is no longer
- 19 a default or failure to comply or the diversion has been
- 20 corrected, or, if the compliance or correction is impossible,
- 21 until such grant recipient repays or arranges the repayment
- 22 of the Federal funds which have been improperly diverted
- 23 or expended.

2	SHORT TITLE
3	SEC. 201. This title may be cited as the "Museum Serv-
4	Tices Act" in the feature of the fea
5	office and the first product of Purpose and the first state of the
6	SEC. 202. It is the purpose of this title to encourage
7	and assist museums in their educational role, in conjunction
8	with formal systems of elementary, secondary, and post-
9	secondary education and with programs of nonformal educa-
10	tion for all age groups; to assist museums in modernizing

23	NATIONAL MUSEUM SERVICES BOARD
24	SEC. 204. (a) The Board shall consist of fifteen mem-

- 10 cise such powers as the Board may prescribe.
- 11 (b) There shall be a Deputy Director of the Institute

grams for specific segments of the public such as pro-
grams for urban neighborhoods, rural areas, Indian
reservations, and penal and other State institutions.
(b) Grants under this section may not exceed 75 per
19 centum of the cost of the program for which the grant is
20 made.
CONTRIBUTIONS
SEC. 207. The Institute shall have authority to accept
in the name of the United States, grants, gifts, or bequests
of money for immediate disbursement in furtherance of the
25 functions of the Institute Such grants wifts or hequests after

19	them to the public on a regular basis.
20	TITLE III—CHALLENGE GRANT PROGRAM

22	SEC. 301. The National Foundation on the Arts and

1 "CHALLENGE GRANT PROGRAM
2 "Sec. 12. (a) The Chairman of the National Endow-
3 ment for the Arts and the Chairman of the National Endow-
4 ment for the Humanities, with the advice of the National
5 Council on the Arts and the National Council on the Human-
6 ities, are authorized, in accordance with the provisions of this
7 section, to establish and carry out a program of contracts
8 with, or grants-in-aid to, public agencies and private non-
9 profit organizations for the purpose of—
"(1) enabling cultural organizations and institu-
tions to increase the levels of continuing support and
to increase the range of contributors to the program of
such organizations or institutions;
"(2) providing administrative and management
improvements for cultural organizations and institutions,
particularly in the field of long-range financial planning;
"(3) enabling cultural organizations and institutions
to increase audience participation in, and appreciation
of, programs sponsored by such organizations and insti-
20 tutions;
"(4) stimulating greater cooperation among cul-
22 tural organizations and institutions especially designed to
23: serve better the communities in which such organizations
or institutions are located; and

- "(5) fostering greater citizen involvement in plan-
- 2 ning the cultural development of a community.
- 3 "(b) The total amount of any payment made under this
- 4 section for a program or project may not exceed 50 per
- 5 centum of the cost of such program or project.
  - 6 "(c) In carrying out the program authorized by this
  - 7 section the Chairman of the National Endowment for the
  - 8 Arts and the Chairman of the National Endowment for the
  - 9 Humanities shall have the same authority as is established in
- 10 section 10.".

#### 11 AUTHORIZATION OF APPROPRIATIONS

- SEC. 302. Section 11 (a) of the National Foundation on
- 13 the Arts and the Humanities Act of 1965 is amended by
- 14 adding at the end thereof the following new paragraph:
- 15 "(3) (A) There are authorized to be appropriated for
- 16 each fiscal year ending before October 1, 1981, to the
- 17 National Endowment for the Arts and the National Endow-
- 18 ment for the Humanities an amount equal to the total amounts
- 19 received by each such Endowment for the purposes set forth
- 20 in section 12 (a) pursuant to the authority of section 10 (a)
- 21 (2), except that the amount so appropriated to both such
