You are fully aware of my long-standing interest in libraries and their importance to society. Their function as community information centers increases with each passing year, emphasizing the significance of the support they provide to citizens.

It is my intention to introduce legislation in the next Congress calling for a Second White House Conference on Library and Information Services in 1989. This action will raise the Congressional level of awareness and involvement concerning the importance of these institutions. Both members and staff need to become better acquainted with the status and potential of libraries' many roles.
