Mr. Pell introduced the following bill; which was read twice and referred to the Committee on Labor and Public Welfare

A BILL

To improve museum services.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 That this Act may be cited as the "Museum Services Act".
- 4 PURPOSE
- 5 Sec. 2. It is the purpose of this Act to encourage and
- 6 assist museums in their educational role, in conjunction
- 7 with formal systems of elementary, secondary, and post-
- 8 secondary education and with programs of nonformal edu-
- 9 cation for all age groups; to assist museums in modernizing
- 10 their methods and facilities so that they may better be able
- 11 to conserve our cultural, historic, and scientific heritage;

and to ease the financial burden borne by museums as a 1 result of their increasing use by the public. 2 INSTITUTE FOR THE IMPROVEMENT OF MUSEUM SERVICES 3 SEC. 3. There is hereby established, within the Depart-4 ment of Health, Education, and Welfare, an Institute for 5 the Improvement of Museum Services (hereinafter referred 6 to as the "Institute"). The Institute shall consist of a Na-7 tional Museum Services Board (hereinafter referred to as 8 the "Board") and a Director of the Institute (hereinafter referred to as the "Director"). 10 NATIONAL MUSEUM SERVICES BOARD 11 Sec. 4. (a) The Board shall consist of fifteen members 12appointed by the President, by and with the advice and 13 consent of the Senate, and the following ex officio members: 14 (1) the Director; 15 (2) the Librarian of Congress; 16 (3) the Archivist of the United States; 17 (4) the Commissioner of Education; 18 (5) the Secretary of the Smithsonian Institution; 19 (6) the Director of the National Gallery of Art; 20 (7) the Chairman of the National Endowment for 21

- 7 The Director shall be compensated at the rate provided for
- 8 level V of the Executive Schedule under section 5316 of
- 9 title V, United States Code, and shall perform such duties
- 10 and exercise such powers as the Board may prescribe.
- 11 (b) There shall be a Deputy Director of the Insti-
- 12 tute who shall be appointed by the President and shall
- 13 serve at the pleasure of the President. The Deputy Direc-
- 14 tor shall be compensated at the rate provided for grade
- 15 18 of the General Schedule set forth in section 5332 of
- 16 title 5, United States Code. The Deputy Director shall
- 17 exercise such powers as the Director may prescribe, and
- 18 the Deputy Director shall serve as Director during the
- 19 absence or disability of the Director, or in the event of a
- 20 vacancy in the Office of Director. The position created by

- 7 or esthetic purposes, which, utilizing a professional staff,
- 8 owns and utilizes tangible objects, cares for them, and ex-
- 9 hibits them to the public on a regular basis.
