The White House has sent to the Senate a list of nominees for confirmation to serve six-year terms as members of the National Council on the Humanities. As you know, the Council reviews and makes recommendations on grant applications made to the Humanities Endowment. The Council is made up of 24 members with staggered terms so that one-third of the Council members are replaced every two years.

The Senate must approve these nominations, and the process is relatively pro forma. This year, however, members of the Senate have expressed greater interest in the nominees than in the past, and we may see a hearing before the Senate Labor, Health and Human Services Committee on the qualifications of the nominees.
