FLOOR SCRIPT FOR THE WHITE HOUSE CONFERENCE ON LIBRARIES, S.J.  
RES. 26

Chair: "We will now proceed to consider Calendar Order 309, S.J.  
Res. 26"

Chair: "The clerk will report"

Bill Clerk: (Reads Title)

**PELL: READS OPENING STATEMENT**

(Yields floor to Stafford and other members for opening  
statements)

**PELL: Mr. President, I wish to offer an amendment on behalf of  
all the members of the Labor and Human Resources  
Committee. I send the amendment to the desk and ask for  
its immediate consideration."**

Chair: The clerk will report the amendment.

Bill Clerk: starts to read amendment

**PELL: I ask unanimous consent that further reading of the  
amendment be dispensed with.**

Chair: Without objection, so ordered.

**PELL: Reads statement on Committee amendment.**

Chair: Is there objection to the adoption of the amendment?  
Hearing none, the amendment is agreed to.

**PELL:** I Move to reconsider the vote by which the amendment was agreed to.

Minority Floor Manager: Mr. President, I move to lay the motion on the table.

Chair: Without objection, the motion to table is agreed to.

(Other amendments may be offered at this point).
