Brown University Library

The John Hay Library is the fourth home for the Library of Brown University, which dates from 1767, three years after the founding of the University. The first home of the Library was an east room on the second floor of University Hall. During the Revolution, the College was disbanded and the books were placed in storage in Wrentham, Mass.—according to legend in the drawer of a kitchen table.

In 1782 the books were returned to University Hall where they stayed until 1835, when the Library was moved to the first floor of Manning Hall, which had been built in 1834 as a Chapel and Library. By 1878 this was outgrown and a new Library building was built on the corner of Prospect and Waterman Streets, what is now known as the Economics Building. This was outgrown very rapidly and the John Hay Library was built in 1910 by the gifts of Andrew Carnegie and a group of friends and Alumni of Brown University.

In 1939 an extension was added, built from funds contributed by Colonel Webster Knight, Mr. William T. Peck, and Mr. Zechariah Chafee, providing two more reading rooms and six stack floors, and making possible a reorganization throughout the whole building.

Other libraries on the campus which are part of the Main Library system are the Divisional Library of Mathematics, Physical Sciences and Engin-

earing in the Metcalf Research Laboratory, the Divisional Library of Biological Sciences in the Arnold Biological Laboratory, and Pembroke College Library in Pembroke Hall.

Providence Athenaeum

On September 28, the Providence Athenaeum held its one hundred and seventh annual meeting of shareholders. The Board of Directors announced that the year had been a satisfactory one, with a circulation almost as high as the preceding year, in spite of the war. In some classifications, there was an actual increase, which was particularly marked in history and in current events.

Gratitude for her loyal service these 33 years cannot be adequately voiced, but rather is felt by all those who have benefited from it.

Under Mrs. Wyman's able leadership there is assurance that the library will continue to serve the community and to progress.
