MEETING THE DEMAND: TRAINING AND GUIDANCE FOR GENERAL OPERATING
SUPPORT FIELD REVIEWERS.

The Institute of Museum Services is offering a series of workshops to strengthen and improve the reviewing skills of GOS field reviewers. The first of the series were offered at the American Association of Museums Conference in New Orleans, LA and the American Association of Botanical Gardens and Arboreta Conference in Atlanta, GA. and were enthusiastically received.
