Report of Faculty Senate Calendar Committee

- I. Calendar change for present spring semester, 1963-64.
  - A. The Committee recommends the following changes:
    1. 

May 25 - May 29	Senior examinations
May 25 - June 4	Undergraduate examinations
May 30, Saturday	Holiday, Memorial Day
June 1, Monday	Grades due for degree candidates, 9:00 a.m.
    - a. Since the first examination day is on a Monday, Saturday afternoon and Sunday are available as "reading day."
    - b. The examination period provides for the scheduling of common examinations for multiple section courses.
  - B. The calendar changes in section A, above, were recommended by the Deans' Council which met with the Executive Committee of the Faculty Senate and the Calendar Committee.
