## AUTHORIZATIONS OF APPROPRIATIONS

2       SEC. ~~103.~~ 102. (a) (1) (A) Section 11(a) (1) (A) of  
3 the National Foundation on the Arts and the Humanities Act  
4 of 1965 is amended to read as follows:

5       "SEC. 11. (a) (1) (A) For the purpose of carrying out  
6 section 5, there are authorized to be appropriated ~~\$113,-~~  
7 ~~500,000~~ each for the fiscal years ~~1977~~ and ~~1978~~ \$100,000,-  
8 000 for fiscal year 1977, and \$113,500,000 for fiscal year  
9 1978; and there are so authorized such sums as may be  
10 necessary for the fiscal years ~~1979,~~ 1979 and 1980. Of the  
11 sums so appropriated for any fiscal year— year, not less than  
12 20 per centum shall be for carrying out section 5(g)."

13       ~~"(i) not less than 20 per centum shall be for ear-~~  
14 ~~rying out section 5(g); and~~

15       ~~"(ii) 4 per centum shall be for carrying out sec-~~

17       (B) Section 11(a) (1) (B) of such Act is amended  
18 by striking out all that follows "Humanities" and inserting  
19 in lieu thereof the following: "~~\$113,500,000~~ each for fiscal  
20 years ~~1977~~ and ~~1978~~ \$100,000,000 for fiscal year 1977, and  
21 \$113,500,000 for fiscal year 1978; and there are so author-  
22 ized such sums as may be necessary for the fiscal years 1979  
23 and 1980. Of the sums so appropriated for any fiscal year,  
24 not less than ~~40~~ 20 per centum shall be for carrying out sec-  
tion 7 (f)."

1           (2) Section 11 (a) (2) of such Act is amended (A) by  
2 striking out "July 1, 1976" and inserting in lieu thereof  
3 "October 1, 1980" and (B) by striking out all that follows  
4 "not exceed" and inserting in lieu thereof "~~\$25,000,000~~  
5 "\$20,000,000 for the fiscal year ending September 30, 1977,  
6 \$25,000,000 for the fiscal year ending September 30, 1978,  
7 and such sums as may be necessary for the fiscal years ending  
8 September 3, 1979, and September 30, 1980."

9           (b) The amendments made by subsection (a) shall be  
10 effective on and after the last day of fiscal year 1976,
