Dear Liv, Bob Wade, and Charles Nixon,

This is but another week and while I am grateful that at least a widdled-down back-pay check has arrived (I continue to ask for interest, moving expenses, damages, etc), I am still forced to bring to your attention, though it is specifically mandated and ordered in the Civil Service Manual, and though it should flow automatically from the MSPB order of Ap 9th, I still have no job, job description, and reporting date of a post comparable to the one I was illegally separated from over two years ago. This puts in question the Endowments good faith. I insist my leave not be used as I have no job to take leave from. I ask confirmation of my status as on paid administrative leave at the pleasure of Chairman Biddle as it is certainly not my fault I have no job or reporting date after over 2 years of litigation and appeal. I also ask full legal fees for as long as this takes as indicated in my lawyers Appeal to MSPB.

I realize Chairman Biddle leaves in November. I have been advised by my Senator to be "prudent" and by the White House to follow channels. I continue in good faith to do so. But I see no reason for further delay.
