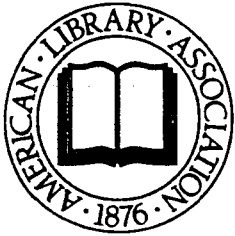

Library Services and Technology Act *Comparison of House and Senate Bills* as of July 20, 1995

Legislation that would renew and restructure the Library Services and Construction Act is pending in both House and Senate. The bills would incorporate fully (S. 856) or partially (H.R. 1617) the Library Services and Technology Act proposed by the American Library Association, the Chief Officers of State Library Agencies, and the Urban Libraries Council. The different House and Senate approaches are analyzed and compared below.
