Help! Please, I have no such letter and do not wish to be harassed to get to Washington to settle, in fact while they did write a completely "sophisticated" letter to me on such pay, they had it so wrong they had me owing them \$19,000 (is incorrect) rather than they owing me \$8,000. They have not to date paid me any information on when I am to be reinstated, though they told MSPB I had been. I have not as I am still in hospital waiting for notice and back pay which they ignore. I have asked my lawyers to try to straighten it out. It is harassment or incompetence, I fear. What has happened to the Agency is former record for exactitude and efficiency? Or am I a special case? Anytime you need testimony on NSA, please let me know I'll provide!

Thanks for trying. I'll keep you informed. They should feel they've paid us all. If not produce.
