MR. GEORGE C. SEYBOLT, (CHAIRMAN), Chairman, William Underwood Company, One Red Devil Lane, Westwood, Massachusetts 02090, (617) 329-5300.

Mr. Seybolt is Immediate Past-Chairman of the American Association of Museums' Trustee Committee; President Emeritus, Museum of Fine Arts, Boston; member of Council, National Endowment for the Arts, 1974-1980; and, Member of Business Committee for the Arts. His appointment is from December 1977 to December 1982.

MR. GARY K. CLARKE, Director, Topeka Zoological Park, 635 Gage Boulevard, Topeka, Kansas 66606, (913) 272-5821.

Mr. Clarke entered the zoo profession in 1957 and was appointed Director of the Topeka Zoological Park in 1963. His Tropical Rain Forest received the National Exhibit Achievement Award in 1974. He is Past President of the American Association of Zoological Parks and Aquariums (AAZPA), and serves on the Board of Regents of the AAZPA Management School. He has traveled to India and the Amazon, and leads photographic safaris to Africa each year. His appointment is from December 1977 to December 1980.

Mr. Davis is a winner of the Architects Firm Award, 1975; Adjunct Professor, the Cooper Union School of Architecture; Visiting Professor, University of Pennsylvania School of Architecture; and Visiting Lecturer, Harvard Graduate School of Design, Clemson University, Massachusetts Institute of Technology, Princeton University, Rhode Island School of Design, University of Illinois, and University of Pennsylvania. Mr. Davis won the Louis Sullivan Award for Architecture in 1977. His appointment is from December 1977 to December 1981.

Mr. Dillon has been active in the affairs of the museum since 1951, when he was first elected Trustee, and served on various committees until he was elected President on January 1, 1970. He was elected Chairman in 1977. He is a Managing Director of Dillon, Read and Company, Inc., and is Chairman of U.S. and Foreign Securities Corporation. Mr. Dillon has been

Ambassador to France, Deputy Under Secretary of State, Under Secretary of State and Secretary of the Treasury. His appointment is from December 1978 to December 1983.

Mrs. Ferst is a Trustee of the High Museum of Art in Atlanta; Trustee of the Atlanta Arts Alliance, Inc. (umbrella organization for the High Museum, the Atlanta Symphony Orchestra, the Atlanta College of Art and the Alliance Theatre); member of the American Association of Museums Trustee Committee; Board member for the Georgia Citizens for the Arts; Georgia representative for the National Advocates Committee of the American Council for the Arts; former Chairman of the Board of the Atlanta Arts Festival, Inc.; Atlanta Woman of the Year in Art (1968). She was active in support of the legislation creating the Institute of Museum Services. Her appointment is from December 1977 to December 1980.

Dr. Harris serves on the Boards of the American Council of Learned Societies, the Henry du Pont Winterthur Museum, and the Dunlap Society. He is a member of the Smithsonian Council, and Chairman of the Organization of American Historian's Historic Preservation Committee. He lectures on various aspects of American history at numerous colleges and universities. His appointment is from December 1978 to December 1983.
