This course synthesizes information already being taught in several courses, and is therefore adequately covered by library resources. The important development in this area is the addition of a computer lab to elaborate and emphasize the use of statistical packages, and it will therefore not change the Libraries response to the needs of the department.

URI alone does not provide all the material needed in this area, but when combined with the HELIN libraries, there is adequate material. Books can be identified under the topics in the syllabus as well as under such diverse headings as Bisexual, Counseling of; Cross cultural counseling; Family psychotherapy; Gays, Counseling of; Lesbians, Counseling of; Minorities-Family relationships; Psychotherapy; Women-mental healsth or Women-psychology or Women-Social conduct. Books are selected not only through the PSY allocation but also in HDF, SOC, WMS.

The current allocation for book materials in the Department is \$14,560.

2. Does URI have the essential journals as noted in the Faculty Questionnaire?

All of the titles listed are available at URI, and almost all years are available electronically.

3. What new resources are required to support the program (including media, electronic, or other non-print materials)?

None have been idneitfieed, but new attention will be paid for media resources.
