# A BILL

To provide for museum and library services.

- 1 Be it enacted by the Senate and House of Representa-
- 2 tives of the United States of America in Congress assembled,
- 3 SECTION 1. SHORT TITLE.
- 4 This Act may be cited as the "Museum and Library
- 5 Services Act of 1996".
- 6 SEC. 2. MUSEUM AND LIBRARY SERVICES.
- 7 The Museum Services Act (20 U.S.C. 961 et seq.)
- 8 is amended to read as follows:

### "TITLE II—MUSEUM AND 1 LIBRARY SERVICES 2 "Subtitle A—General Provisions 3 "SEC. 201. SHORT TITLE. "This title may be cited as the 'Museum and Library 5 Services Act'. 7 "SEC. 202. GENERAL DEFINITIONS. 8 "As used in this title: 9 "(1) COMMISSION.—The term 'Commission' 10 means the National Commission on Libraries and 11 Information Science established under section 3 of 12 the National Commission on Libraries and Informa-13 tion Sciences Act (20 U.S.C. 1502). 14 "(2) DIRECTOR.—The term 'Director' means the Director of the Institute appointed under section 15 16 204. "(3) Institute.—The term 'Institute' means 17 18 the Institute of Museum and Library Services estab-19 lished under section 203. 20 "(4) MUSEUM BOARD.—The term 'Museum

Board' means the National Museum Services Board

established under section 275.

1	"SEC 203	INSTITUTE	OF MUSEUM	AND LIBRARY	SERVICES
1	SEC. 200.	INSTITUTE	OF MIOSEOM	AND LIDRARI	SERVICES.

- 2 "(a) Establishment.—There is established, within
- 3 the National Foundation on the Arts and the Humanities,
- 4 an Institute of Museum and Library Services.
- 5 "(b) Offices.—The Institute shall consist of an Of-
- 6 fice of Museum Services and an Office of Library Services.
- 7 There shall be a National Museum Services Board in the
- 8 Office of Museum Services.

#### 9 "SEC. 204. DIRECTOR OF THE INSTITUTE.

- 10 "(a) APPOINTMENT.—
- 11 "(1) IN GENERAL.—The Institute shall be
- headed by a Director, appointed by the President, by
- and with the advice and consent of the Senate.
- 14 "(2) TERM.—The Director shall serve for a
- term of 4 years.
- 16 "(3) QUALIFICATIONS.—Beginning with the
- first individual appointed to the position of Director
- after the date of enactment of the Museum and Li-

- 3 "(b) Compensation.—The Director shall be com-
- 4 pensated at the rate provided for level III of the Executive
- 5 Schedule under section 5314 of title 5, United States
- 6 Code.
- 7 "(c) Duties and Powers.—The Director shall per-
- 8 form such duties and exercise such powers as may be pre-
- 9 scribed by law, including awarding financial assistance for
- 10 activities described in this title.
- 11 "(d) Nondelegation.—The Director shall not dele-
- 12 gate any of the functions of the Director to any person
- 13 who is not an officer or employee of the Institute.
- 14 "(e) COORDINATION.—The Director shall ensure co-
- 15 ordination of the policies and activities of the Institute
- 16 with the policies and activities of other agencies and of-
- 17 fices of the Federal Government having interest in and
- 18 responsibilities for the improvement of museums and li-
- 19 braries and information services.
- 20 "SEC. 205. DEPUTY DIRECTORS.
- 21 "The Office of Library Services shall be headed by
- 22 a Deputy Director, who shall be appointed by the Director
- 23 from among individuals who have a graduate degree in
- 24 library science and expertise in library and information
- 25 services. The Office of Museum Services shall be headed

- 1 by a Deputy Director, who shall be appointed by the Di-
- 2 rector from among individuals who have expertise in mu-
- 3 seum services.

#### 4 "SEC. 206. PERSONNEL.

- 5 "(a) IN GENERAL.—The Director may, in accordance
- 6 with applicable provisions of title 5, United States Code,
- 7 appoint and determine the compensation of such employ-
- 8 ees as the Director determines to be necessary to carry
- 9 out the duties of the Institute.
- 10 "(b) Voluntary Services.—The Director may ac-
- 11 cept and utilize the voluntary services of individuals and
- 12 reimburse the individuals for travel expenses, including
- 13 per diem in lieu of subsistence, in the same amounts and
- 14 to the same extent as authorized under section 5703 of
- 15 title 5, United States Code, for persons employed intermit-
- 16 tently in Federal Government service.

#### 17 "SEC. 207. CONTRIBUTIONS.

- 18 "The Institute is authorized to solicit, accept, receive,
- 19 and invest in the name of the United States, gifts, be-
- 20 quests, or devises of money and other property or services
- 21 and to use such property or services in furtherance of the
- 22 functions of the Institute. Any proceeds from such gifts,
- 23 bequests, or devises, after acceptance by the Institute,
- 24 shall be paid by the donor or the representative of the
- 25 donor to the Director. The Director shall enter the pro-

1	ceeds in a special-interest bearing account to the credit
2	of the Institute for the purposes specified in each case.
3	"Subtitle B—Library Services and
4	Technology
5	"SEC. 211. SHORT TITLE.
6	"This subtitle may be cited as the 'Library Services
7	and Technology Act'.
8	"SEC. 212. PURPOSE.
9	"It is the purpose of this subtitle—
10	"(1) to consolidate Federal library service pro-
11	grams;
12	"(2) to stimulate excellence and promote access
13	to learning and information resources in all types of
14	libraries for individuals of all ages;
15	"(3) to promote library services that provide all
16	users access to information through State, regional,
17	national and international electronic networks;
18	"(4) to provide linkages among and between li-
19	braries and one-stop career center systems; and
20	"(5) to promote targeted library services to peo-
21	ple of diverse geographic, cultural, and socio-
22	economic backgrounds, to individuals with disabil-

1	"SEC. 213. DEFINITIONS.
2	"As used in this subtitle:
3	"(1) Indian tribe.—The term 'Indian tribe
4	means any tribe, band, nation, or other organized
5	group or community, including any Alaska native
6	village, regional corporation, or village corporation
7	as defined in or established pursuant to the Alaska
8	Native Claims Settlement Act (43 U.S.C. 1601 e
9	seq.), which is recognized by the Secretary of the In
10	terior as eligible for the special programs and serv
11	ices provided by the United States to Indians be
12	cause of their status as Indians.
13	"(2) Library.—The term 'library' includes—
14	"(A) a public library;
15	"(B) a public elementary school or second
16	ary school library;
17	"(C) an academic library;
18	"(D) a research library, which for the pur
19	poses of this subtitle means a library that—
20	"(i) makes publicly available library
21	services and materials suitable for schol
22	arly research and not otherwise available
23	to the public; and
24	"(ii) is not an integral part of an in-

stitution of higher education; and

. 1	"(E) a private library, but only if the State
2	in which such private library is located deter-
3	mines that the library should be considered a li-
4	brary for purposes of this subtitle.
5	"(3) LIBRARY CONSORTIUM.—The term 'library
6	consortium' means any local, statewide, regional,
7	interstate, or international cooperative association of
8	library entities which provides for the systematic and
9	effective coordination of the resources of school, pub-
10	lic, academic, and special libraries and information
11	centers, for improved services for the clientele of
12	such library entities.
13	"(4) STATE.—The term 'State', unless other-
14	wise specified, includes each of the 50 States of the
15	United States, the District of Columbia, the Com-
16	monwealth of Puerto Rico, the United States Virgin
17	Islands, Guam, American Samoa, the Common-
18	wealth of the Northern Mariana Islands, the Repub-
19	lic of the Marshall Islands, the Federated States of
20	Micronesia, and the Republic of Palau.
21	"(5) STATE LIBRARY ADMINISTRATIVE AGEN-
22	CY.—The term 'State library administrative agency'
23	means the official agency of a State charged by the
24	law of the State with the extension and development
25	of public library services throughout the State.

1	"(6) STATE PLAN.—The term 'State plan'
2	means the document which gives assurances that the
3	officially designated State library administrative
4	agency has the fiscal and legal authority and capa-
5	bility to administer all aspects of this subtitle, pro-
6	vides assurances for establishing the State's policies,
7	priorities, criteria, and procedures necessary to the
8	implementation of all programs under this subtitle,
9	submits copies for approval as required by regula-
10	tions promulgated by the Director, identifies a
11	State's library needs, and sets forth the activities to
12	be taken toward meeting the identified needs sup-
13	ported with the assistance of Federal funds made
14	available under this subtitle.
15	"SEC. 214. AUTHORIZATION OF APPROPRIATIONS.
16	"(a) Authorization of Appropriations.—
17	"(1) In general.—There are authorized to be
18	appropriated \$150,000,000 for fiscal year 1997 and
19	such sums as may be necessary for each of the fiscal
20	years 1998 through 2002 to carry out this subtitle.
21	"(2) Transfer.—The Secretary of Education
22	shall—
23	"(A) transfer any funds appropriated

3	"(B) not exercise any authority concerning
4	the administration of this title other than the

6	"(b) Forward Funding.—
7	"(1) IN GENERAL.—To the end of affording the
8	responsible Federal, State, and local officers ade
9	quate notice of available Federal financial assistance
10	for carrying out ongoing library activities and
11	projects, appropriations for grants, contracts, or
12	other payments under any program under this sub-
13	title are authorized to be included in the appropria-
14	tions Act for the fiscal year preceding the fiscal year
15	during which such activities and projects shall be
16	carried out.
17	"(2) Additional authorization of appro-
18	PRIATIONS.—In order to effect a transition to the
19	timing of appropriation action authorized by sub-
20	section (a), the application of this section may result
21	in the enactment, in a fiscal year, of separate appro-
22	priations for a program under this subtitle (whether
23	in the same appropriations Act or otherwise) for two
24	consecutive fiscal years.

1	"(c) Administration.—Not more than 3 percent of
2	the funds appropriated under this section for a fiscal year
3	may be used to pay for the Federal administrative costs
4	of carrying out this subtitle.
5	"CHAPTER 1—BASIC PROGRAM
6	REQUIREMENTS
7	"SEC. 221. RESERVATIONS AND ALLOTMENTS.
8	"(a) Reservations.—
9	"(1) In general.—From the amount appro-
0	priated under the authority of section 214 for any
l 1	fiscal year, the Director—
12	"(A) shall reserve 1½ percent to award
13	grants in accordance with section 261; and
4	"(B) shall reserve 4 percent to award na-
5	tional leadership grants or contracts in accord-
6	ance with section 262.
7	"(2) Special rule.—If the funds reserved
8	pursuant to paragraph (1)(B) for a fiscal year have
9	not been obligated by the end of such fiscal year,
20	then such funds shall be allotted in accordance with
21	subsection (b) for the fiscal year succeeding the fis-
22	cal year for which the funds were so reserved.
23	"(b) Allotments.—
24	"(1) In General.—From the sums appro-
25	priated under the authority of section 214 and not

reserved under subsection (a) for any fiscal year, the Director shall award grants from minimum allotments, as determined under paragraph (3), to each State. Any sums remaining after minimum allotments are made for such year shall be allotted in the manner set forth in paragraph (2).

"(2) Remainder.—From the remainder of any sums appropriated under the authority of section 214 that are not reserved under subsection (a) and not allotted under paragraph (1) for any fiscal year, the Director shall award grants to each State in an amount that bears the same relation to such remainder as the population of the State bears to the population of all States.

#### "(3) MINIMUM ALLOTMENT.—

"(A) IN GENERAL.—For the purposes of this subsection, the minimum allotment for each State shall be \$340,000, except that the minimum allotment shall be \$40,000 in the case of the United States Virgin Islands, Guam, American Samoa, the Commonwealth of the Northern Mariana Islands, the Republic of the Marshall Islands, the Federated States of Micronesia, and the Republic of Palau.

"(B) RATABLE REDUCTIONS.—If the sum appropriated under the authority of section 214 and not reserved under subsection (a) for any fiscal year is insufficient to fully satisfy the aggregate of the minimum allotments for all States for that purpose for such year, each of such minimum allotments shall be reduced ratably.

### "(C) SPECIAL RULE.—

"(i) IN GENERAL.—Notwithstanding any other provision of this subsection and using funds allotted for the Republic of the Marshall Islands, the Federated States of Micronesia, and the Republic of Palau under this subsection, the Director shall award grants to Guam, American Samoa, the Commonwealth of the Northern Mariana Islands, the Republic of the Marshall Islands, the Federated States of Micronesia, or the Republic of Palau to carry out activities described in this subtitle in accordance with the provisions of this subtitle that the Director determines are not inconsistent with this subparagraph.

1	"(ii) AWARD BASIS.—The Director
2	shall award grants pursuant to clause (i
3	on a competitive basis and pursuant to rec
4	ommendations from the Pacific Region
5	Educational Laboratory in Honolulu, Ha
6	waii.
7	"(iii) TERMINATION OF ELIGI
8	BILITY.—Notwithstanding any other provi-
9	sion of law, the Republic of the Marshal
10	Islands, the Federated States of Microne
11	sia, and the Republic of Palau shall not re-
12	ceive any funds under this subtitle for any
13	fiscal year that begins after September 30
14	2001.
15	"(iv) Administrative costs.—The
16	Director may provide not more than 5 per-
17	cent of the funds made available for grants
18	under this subparagraph to pay the admin
19	istrative costs of the Pacific Region Edu-
20	cational Laboratory regarding activities as-
21	sisted under this subparagraph.
22	"(4) Data.—The population of each State and
23	of all the States shall be determined by the Director
24	on the basis of the most recent data available from
25	the Bureau of the Census.

1	"SEC. 222. ADMINISTRATION.
2	"(a) In General.—Not more than 4 percent of the
3	total amount of funds received under this subtitle for any
4	fiscal year by a State may be used for administrative costs.
5	"(b) Construction.—Nothing in this section shall
6	be construed to limit spending for evaluation costs under
7	section 224(c) from sources other than this subtitle.
8	"SEC. 223. PAYMENTS; FEDERAL SHARE; AND MAINTE-
9	NANCE OF EFFORT REQUIREMENTS.
10	"(a) Payments.—The Director shall pay to each
11	State library administrative agency having a State plan
12	approved under section 224 the Federal share of the cost
13	of the activities described in the State plan.
14	"(b) Federal Share.—
15	"(1) IN GENERAL.—The Federal share shall be
16	66 percent.
17	"(2) Non-federal share.—The non-federal
18	share of payments shall be provided from non-Fed-
19	eral, State, or local sources.
20	"(c) Maintenance of Effort.—
21	"(1) State expenditures.—
22	"(A) REQUIREMENT.—
23	"(i) IN GENERAL.—The amount oth-
24	erwise payable to a State for a fiscal year
25	pursuant to an allotment under this chap-
26	ter shall be reduced if the level of State ex-

1	penditures, as described in paragraph (2),
2	for the previous fiscal year is less than the
3	average of the total of such expenditures
4	for the 3 fiscal years preceding that pre-
5	vious fiscal year. The amount of the reduc-
6	tion in allotment for any fiscal year shall
7	be equal to the amount by which the level
8	of such State expenditures for the fiscal
9	year for which the determination is made
10	is less than the average of the total of such
11	expenditures for the 3 fiscal years preced-
12	ing the fiscal year for which the determina-
13	tion is made.
14	"(ii) CALCULATION.—Any decrease in
15	State expenditures resulting from the ap-
16	plication of subparagraph (B) shall be ex-
17	cluded from the calculation of the average
18	level of State expenditures for any 3-year
19	period described in clause (i).
20	"(B) Decrease in Federal support.—
21	If the amount made available under this sub-
22	title for a fiscal year is less than the amount
23	made available under this subtitle for the pre-
24	ceding fiscal year, then the expenditures re-
25	quired by subparagraph (A) for such preceding

1	fiscal year shall be decreased by the same per-
2	centage as the percentage decrease in the
3	amount so made available.
4	"(2) LEVEL OF STATE EXPENDITURES.—The
5	level of State expenditures for the purposes of para-
6	graph (1) shall include all State dollars expended by
7	the State library administrative agency for library
8	programs that are consistent with the purposes of
9	this subtitle. All funds included in the maintenance
10	of effort calculation under this subsection shall be
11	expended during the fiscal year for which the deter-
12	mination is made, and shall not include capital ex-
13	penditures, special one-time project costs, or similar
14	windfalls.
15	"(3) WAIVER.—The Director may waive the re-
16	quirements of paragraph (1) if the Director deter-
17	mines that such a waiver would be equitable due to
18	exceptional or uncontrollable circumstances such as
19	a natural disaster or a precipitous and unforeseen
20	decline in the financial resources of the State.
21	"SEC. 224. STATE PLANS.
22	"(a) State Plan Required.—
23	"(1) IN GENERAL.—In order to be eligible to
24	receive a grant under this subtitle, a State library

1	administrative agency shall submit a State plan to
2	the Director not later than April 1, 1997.
3	"(2) DURATION.—The State plan shall cover a
4	period of 5 fiscal years.
5	"(3) Revisions.—If a State library administra-
6	tive agency makes a substantive revision to its State
7	plan, then the State library administrative agency
8	shall submit to the Director an amendment to the
9	State plan containing such revision not later than
10	April 1 of the fiscal year preceding the fiscal year
11	for which the amendment will be effective.
12	"(b) Contents.—The State plan shall—
13	"(1) establish goals, and specify priorities, for
14	the State consistent with the purposes of this sub-
15	title;
16	"(2) describe activities that are consistent with
17	the goals and priorities established under paragraph
18	(1), the purposes of this subtitle, and section 231,
19	that the State library administrative agency will
20	carry out during such year using such grant;
21	"(3) describe the procedures that such agency
22	will use to carry out the activities described in para-
23	graph (2);
24	"(4) describe the methodology that such agency
25	will use to evaluate the success of the activities es-

1	tablished under paragraph (2) in achieving the goals
2	and meeting the priorities described in paragraph
3	(1);
4	"(5) describe the procedures that such agency
5	will use to involve libraries and library users
6	throughout the State in policy decisions regarding
7	implementation of this subtitle; and
8	"(6) provide assurances satisfactory to the Di-
9	rector that such agency will make such reports, in
10	such form and containing such information, as the
11	Director may reasonably require to carry out this
12	subtitle and to determine the extent to which funds
13	provided under this subtitle have been effective in
14	carrying out the purposes of this subtitle.
15	"(c) EVALUATION AND REPORT.—Each State library
16	administrative agency receiving a grant under this subtitle
17	shall independently evaluate, and report to the Director
18	regarding, the activities assisted under this subtitle, prior
19	to the end of the 5-year plan.
20	"(d) Information.—Each library receiving assist-
21	ance under this subtitle shall submit to the State library
22	administrative agency such information as such agency
23	may require to meet the requirements of subsection (c).

"(e) APPROVAL.—

24

1	"(1) In General.—The Director shall approve
2	any State plan under this subtitle that meets the re-
3	quirements of this subtitle and provides satisfactory
4	assurances that the provisions of such plan will be
5	carried out.
6	"(2) PUBLIC AVAILABILITY.—Each State li
7	brary administrative agency receiving a grant under
8	this subtitle shall make the State plan available to
9	the public.
10	"(3) Administration.—If the Director deter-
11	mines that the State plan does not meet the require-
12	ments of this section, the Director shall—
13	"(A) immediately notify the State library
14	administrative agency of such determination
15	and the reasons for such determination;
16	"(B) offer the State library administrative
17	agency the opportunity to revise its State plan
18	"(C) provide technical assistance in order
19	to assist the State library administrative agency
20	in meeting the requirements of this section; and
21	"(D) provide the State library administra-
22	tive agency the opportunity for a hearing.

# 1 "CHAPTER 2—LIBRARY PROGRAMS

2	"SEC. 231. GRANTS TO STATES.
3	"(a) In General.—Of the funds provided to a State
4	library administrative agency under section 214, such
5	agency shall expend, either directly or through subgrants
6	or cooperative agreements, at least 96 percent of such
7	funds for—
8	"(1)(A) establishing or enhancing electronic
9	linkages among or between libraries;
10	"(B) electronically linking libraries with edu-
11	cational, social, or information services;
12	"(C) assisting libraries in accessing information
13	through electronic networks;
14	"(D) encouraging libraries in different areas
15	and encouraging different types of libraries, to es-
16	tablish consortia and share resources; or
17	"(E) paying costs for libraries to acquire or
18	share computer systems and telecommunications
19	technologies; and
20	"(2) targeting library and information services
21	to persons having difficulty using a library and to
22	underserved urban and rural communities, including
23	children (from birth through age 17) from families
24	with incomes below the poverty line (as defined by
25	the Office of Management and Budget and revised

1	annually in accordance with section 673(2) of the
2	Community Services Block Grant Act (42 U.S.C.
3	9902(2)) applicable to a family of the size involved.
4	"(b) Special Rule.—Each State library administra-
5	tive agency receiving funds under this chapter may appor-
6	tion the funds available for the purposes described in sub-
7	section (a) between the two purposes described in para-
8	graphs (1) and (2) of such subsection, as appropriate, to
9	meet the needs of the individual State.
10	"CHAPTER 3—ADMINISTRATIVE
11	PROVISIONS
12	"Subchapter A—State Requirements
13	"SEC. 251. STATE ADVISORY COUNCILS.
14	"Each State desiring assistance under this subtitle
15	may establish a State advisory council which is broadly
16	representative of the library entities in the State, including
17	public, school, academic, special, and institutional librar-
8	ies, and libraries serving individuals with disabilities.
19	"Subchapter B—Federal Requirements
20	"SEC. 261. SERVICES FOR INDIAN TRIBES.
21	"From amounts reserved under section 221(a)(1)(A)
22	for any fiscal year the Director shall award grants to orga-
23	nizations primarily serving and representing Indian tribes
24	to enable such organizations to carry out the activities de-
25	scribed in section 231.

1	"SEC. 262. NATIONAL LEADERSHIP GRANTS OR CON-
2	TRACTS.
3	"(a) In General.—From the amounts reserved
4	under section 221(a)(1)(B) for any fiscal year the Direc-
5	tor shall establish and carry out a program awarding na-
6	tional leadership grants or contracts to enhance the qual-
7	ity of library services nationwide and to provide coordina-
8	tion between libraries and museums. Such grants or con-
9	tracts shall be used for activities that may include—
10	"(1) education and training of persons in li-
11	brary and information science, particularly in areas
12	of new technology and other critical needs, including
13	graduate fellowships, traineeships, institutes, or
14	other programs;
15	"(2) research and demonstration projects relat-
16	ed to the improvement of libraries, education in li-
17	brary and information science, enhancement of li-
18	brary services through effective and efficient use of
19	new technologies, and dissemination of information
20	derived from such projects;
21	"(3) preservation or digitization of library ma-
22	terials and resources, giving priority to projects em-
23	phasizing coordination, avoidance of duplication, and
24	access by researchers beyond the institution or li-
25	brary entity undertaking the project; and

1	"(4) model programs demonstrating cooperative
2	efforts between libraries and museums.
3	"(b) Grants or Contracts.—
4	"(1) In General.—The Director may carry
5	out the activities described in subsection (a) by
6	awarding grants to, or entering into contracts with,
7	libraries, agencies, institutions of higher education,
8	or museums, where appropriate.
9	"(2) Competitive basis.—Grants and con-
10	tracts under this section shall be awarded on a com-
11	petitive basis.

9	"SEC. 273. MUSEUM SERVICES ACTIVITIES.
10	"(a) Grants.—The Director, subject to the policy di-
11	rection of the Museum Board, may make grants to muse-
12	ums to pay for the Federal share of the cost of increasing
13	and improving museum services, through such activities
14	as—
15	"(1) programs that enable museums to con-
16	struct or install displays, interpretations, and exhibi-
17	tions in order to improve museum services provided
18	to the public;
19	"(2) assisting museums in developing and
20	maintaining professionally trained or otherwise expe-
21	rienced staff to meet the needs of the museums;
22	"(3) assisting museums in meeting the adminis-
23	trative costs of preserving and maintaining the col-

2	the public through the use of the collections;
3	"(4) assisting museums in cooperating with

9	"(6) developing and carrying out specialized
10	programs for specific segments of the public, such as
11	programs for urban neighborhoods, rural areas, In-

14	"(7) model programs demonstrating cooperative
15	efforts between libraries and museums.
16	"(b) Contracts and Cooperative Agree-
17	MENTS.—
18	"(1) Projects to strengthen museum
19	SERVICES.—The Director, subject to the policy di-
20	rection of the Museum Board, is authorized to enter
21	into contracts and cooperative agreements with ap-
22	propriate entities, as determined by the Director, to
23	pay for the Federal share of enabling the entities to
24	undertake projects designed to strengthen museum
25	services, except that any contracts or cooperative

1	agreements entered into pursuant to this subsection
2	shall be effective only to such extent or in such
3	amounts as are provided in appropriations Acts.

4	financial assistance under this subtitle shall not be subject

6	"SEC. 274. AWARD.

11	"SEC. 275. NATIONAL MUSEUM SERVICES BOARD.
12	"(a) Establishment.—There is established in the
13	Institute a National Museum Services Board.
