It has come to my attention that Dr. Maria Moreira Ellen of the Foreign Literature and Languages Department at Southeastern Massachusetts University has recently submitted an application to the NEH requesting funding for a summer seminar in 1991. The grant request has been made to the Division of Education Programs.

The proposed seminar, which will be on the topic of the "Internationalization of Portuguese Studies", will offer sessions on the history, culture and literature of the main countries of Portuguese expression. It will bring to the host university many recognized scholars who will share their extensive expertise with the participating high school teachers. Government and academic leaders from Portugal, Mozambique and Brasil will also participate as distinguished visiting lecturers.
