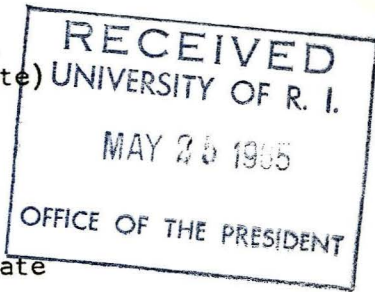

Change of Dates for Honors Day Convocations

It is recommended that the dates for Honors Day Convocations be changed as found in the original report contained in the Faculty Senate Agenda dated February 18, 1965.

The Recommended change follows:

1966-67 Calendar	Oct. 25, Tuesday	Oct. 27, Thursday
1967-68 Calendar	Oct. 24, Tuesday	Oct. 26, Thursday

Since the Faculty Senate has designated that classes not be held from 1:00 P.M. to 2:00 P.M. on each Thursday, for the purpose of scheduling convocations and other meetings, it is most appropriate to change the Honors Day Convocations from Tuesdays to Thursdays.
