MILITARY PROCUREMENT

Committee on Armed Services: Subcommittee on Research and Development, in closed session, considered its portion of S. 2965, authorizing funds for military procurement for fiscal year 1977, but did not complete action thereon and recessed subject to call.

FEA EXTENSION

Committee on Government Operations: Committee began hearings on S. 2872, to extend until September 30, 1979, the authority of the Federal Energy Administration, receiving testimony from Elmer B. Staats, Comptroller General, who was accompanied by his associates, all of the General Accounting Office; Hazel Rollins, Director, Office of Consumer Affairs and Roger Sant, Assistant Administrator, both of Federal Energy Administration.

Hearings continue tomorrow.

ENERGY CONSERVATION

Committee on Interior and Insular Affairs: Committee began hearings on S. 2932, to provide energy conservation in residential housing, commercial and public buildings, and commercial plants through federally-supported State energy conservation programs, receiving testimony from Senator Kennedy; Carl Stein, New York City, Energy Task Force of the New York State Association of Architects; Thomas B. Smith and Robert Fuller, both of Ohio State University, Columbus; and Richard Aspenson, Minnesota Mining and Manufacturing Corporation.

Hearings were recessed subject to call.

INTELLIGENCE REPORT

Select Committee on Intelligence Activities: Committee met in closed session to receive testimony from George Bush, Director of Central Intelligence and Edward H. Levi, Attorney General, Department of Justice, following which committee released its final report, "Book I: Foreign and Military Intelligence."

Interparliamentary Union: The Speaker, on April 14, appointed Representatives Hamilton, Satterfield, Jarman, Derwinski, Clancy, and McClory as members of the delegation to attend the conference of the Interparliamentary Union on the part of the House.

Presidential Message—U.S. Footwear: Read a message from the President transmitting to Congress pro-

posals to assist the U.S. footwear industry—referred to the Committee on Ways and Means and ordered printed (H. Doc. 94–458).

Federal-Aid Highway Act: Agreed to H. Con. Res. 618, requesting the return of H.R. 8235 and directing its reenrollment.

Pages H3382—H3383

Energy Conservation in Buildings: The Speaker appointed Representative Stevens a conferee in the conference on H.R. 8650, to assist low-income persons in insulating their homes, to facilitate State and local adoption of energy conservation standards for new buildings, and to direct the Secretary of Housing and Urban Development to undertake research and to develop energy conservation performance standards; to fill the existing vacancy.

Presidential Messages: Read the following messages from the President:

Rural America: Message transmitting to Congress the sixth annual report on Government services to rural America—referred to the Committee on Agriculture and ordered printed with illustrations (H. Doc. 94-459);

HUD: Message transmitting to Congress the eleventh annual report of the Department of Housing and Urban Development—referred to the Committee on Banking, Currency and Housing; and

Upland cotton program: Message transmitting to Congress the report of the 1974 upland cotton program—referred to the Committee on Agriculture. Page H3383

Arts and Humanities: By a yea-and-nay vote 279 yeas to 59 nays, the House passed H.R. 12838, to amend and extend the National Foundation on the Arts and Humanities Act of 1965, to provide for the improvement of museum services, and to establish a challenge grant program.

Agreed to the committee amendment in the nature of a substitute.

An amendment was offered but subsequently withdrawn that sought to add a new title to carry out an emergency program to employ artists during years in which the unemployment rate exceeds 6.5 percent. Previously, a point of order was overruled against the amendment.

H. Res. 1143, the rule under which the bill was considered, was agreed to earlier by a voice vote.

Employment and Training Act: House agreed to H. Res. 1144, providing for the consideration of and 1 hour of debate on H.R. 12987, to authorize appropriations for fiscal year 1976, and for the period beginning July 1, 1976, and ending September 30, 1976, for carrying out title VI of the Comprehensive Employment and Training Act of 1973.

Receive and Sign: The Clerk was authorized to receive messages from the Senate, and the Speaker was authorized to sign enrolled bills and joint resolutions, notwithstanding the adjournment of the House from Monday to Tuesday.

PROPOSALS FOR INCLUSION IN NATIONAL PARK SYSTEM

Committee on Interior and Insular Affairs: Subcommittee on National Parks and Recreation held hearings on the following bills:

H.J. Res. 667 and 685, to authorize the Secretary of the Interior to accept the Saint Paul's Church, Eastchester, in Mount Vernon, New York, for administration as a unit of the National Park System;

H.R. 1600, 10565, and 12497, to establish the Frederick Law Olmstead Home and Office in Brookline, Massachusetts, as a national historic site;

H.R. 9126, to authorize the establishment of the Eugene O'Neill National Historic Site, Danville, Calichusetts, as a national historic site;

H.R. 11180, to authorize a study of the feasibility and desirability of establishing the Kalaupapa Settlement on the State of Hawaii as a unit of the National Park System.

Testimony was heard from Representatives Ottinger, Drinan, Miller of California and Mink; Department of Interior and public witnesses.

KANOPOLIS UNIT OF PICK-SLOAN MISSOURI BASIN

Committee on Interior and Insular Affairs: Subcommittee on Water and Power Resources held a hearing on H.R. 7044, to authorize the Secretary of Interior to construct, operate, and maintain the Kanopolis Unit of the Pick-Sloan Missouri Basin program, Kansas. Testimony was heard from Representatives Sebelius and Shriver; James J. O'Brien, Assistant Commissioner, Bureau of Reclamation; and public witnesses.

LDC DEBTS

Committee on International Relations: Subcommittee on International Trade and Commerce held a hearing on debts of less developed countries. Testimony was heard from Dr. Irving S. Friedman, First National City Bank; and Paul Watson, Overseas Development Council.

U.N. CONFERENCE ON TRADE AND DEVELOPMENT

Committee on International Relations: Subcommittees on International Resources, Food and Energy; on International Economic Policy; on International Organizations; and on International Trade and Commerce held a hearing on United Nations Conference on Trade and
