In the March issue of *American Libraries*, an editorial appeared which touched very close to the Rhode Island heart. Gerald Shield's expressed concern over the failure so far, of librarians and state associations to provide input into the long range planning of the Library Services and Construction Act as amended by PL 91-600. We wonder how many librarians have provided copies of this law to their Boards of Trustees. We wonder how many understand the different aspects of the Rhode Island five year plan as it is now being written: We wonder how much opportunity

OPEN LETTER TO LIBRARIANS from the RILA Executive Bd.

On March 22, 1972, Rep. Theodore F. Low sent an open letter to librarians requesting support of bill H 5059 which would specifically exempt libraries and educational institutions from the provisions of Chapt. 30, Public Laws, 1971.

Chapt. 30 added "display at newsstands or any other business establishment frequented by minors under the age of eighteen (18) years or where said minors are or may be invited as a part of the general public" to the original law on sale or exhibition to minors of indecent publications, pictures, or articles (11-30-10).

An advisory opinion of the Rhode Island Attorney General holds that Chapt. 30 does not apply to libraries. In addition, it is the understanding of the Executive Committee that during hearings testimony including the testimony of those supporting the 1971 act, made it clear that it was not meant to apply to libraries.

Under these conditions and with-  
out going into detail as to  
the constitutionality of either  
the original law (11-30-10) or  
Chapt. 30 the Exec. Comm.  
has taken the position that  
specific exemption of libraries  
and educational institutions as  
proposed in H 5059 is not  
necessary at this time.

The Executive Board is going  
to reply to Representative Low  
and also give an explanation  
of their stand to librarians in  
this Bulletin.

The mail ballot for Vice Pres-  
ident/President-Elect was a  
failure, with only about 50  
persons responding. Therefore,  
the Board decided to declare  
these ballots invalid, and  
hold an election at the Spring  
Meeting. Look for your ballot  
while registering.

The RILA Executive Board held  
its April meeting at Providence  
Public Library on April 12,  
from 10 - 1. Members present

Sally Wilson, Mr. Olsen, and  
Mr. Crosby. Visitors were Mr.  
Elliott Andrews, Mr. Ernest  
Denomme, Mrs. Derryl Johnson  
and Mrs. Anne Parent.

Mr. Andrews reported to the  
Board on activities of the  
Legislature, as it comes up to  
closing time. He particularly  
noted Mr. Low's open letter to  
librarians on H 5059, a bill to  
exempt libraries from the  
provisions of Chap. 30, Public  
Laws 1971 (the Marshall Bill).

Developments in the program  
for the Spring Meeting --  
May 23rd at Bryant College --  
were outlined by Anne Parent.  
A flyer with details will be  
mailed to the membership soon.

## CHILD LEARNING CENTER

Social production has deemed inaptitude as being dumb, un-socialized and sometimes misfit. A doomed category thus developed -- the mentally and morally underprivileged. The sector of society that falls in this group is the lower class. Mental starvation developed from these poor and is kept alive by political and social disadvantages. The real bearers of the crosses are obviously the children -- they are the ones who are morally starved. The children of this society have suffered from this injustice. They show a marked deplorable detention from social progress.

The Child Learning Center, a federally funded educational program, has taken upon itself the task of rectifying this injustice. A program, appropriately named, it was founded by a Library Council who believed that something beneficial could be done with such a program. A deliberation period of three years on the part of the federal government resulted in a program draft and enacting expectations. The Library Council had by then defined the purposes of the program. A



Director, Secretary and 10 Counsellors were chosen to be the actual instruments for adjustment.

The Director was then given the job of first appreciating his crowd, and then working with them. The first need that had to be rectified was getting everyone to appreciate the program. Almost everyone did. A system based on reading,



with clubs and classes disguising this function wherever needed, was set up. The Counsellors and children were directly involved. To appreciate this system of learning one has to be really involved with its working. Although the children seem to benefit immensely from this experiment it is rather concealed in their childish minds that formulate the pleasures of their own world.

To understand these children is to relate to the things they need. One of their basic needs is love. But to know a child is to love him and likewise, vice-versa. The Counsellors have thus been given the task of asking questions, writing reports and generally being inquisitive to the child's nature. Gifts of love and contentment have showered the Counsellors for this effort from the children. The grounds have been attained for mass integrity.

Classes and clubs were and are still being set up to cope with the child's demands. The child needs a lot -- we give as much as we can. The children seem to benefit a lot from the program, but still

there is need for more adult participation. An adult can give a lot. Many of the children crave attention. I believe that this need stems from the absence of complete homes. A home without either parent or a home that benefits little from the parents' presence is like no home at all. What evolves from such a home is a consequence of emotional disturbance.

My one and entire hope is that something can be done before the need expires. This Child Learning Center is a step forward. Maybe a lot more steps can be built. Some of us have built these steps in our minds -- there it's a step forward, but it's not realistic enough. We have to provide a mental force. A force these children can use as a weapon of force against a socialistic and political force.

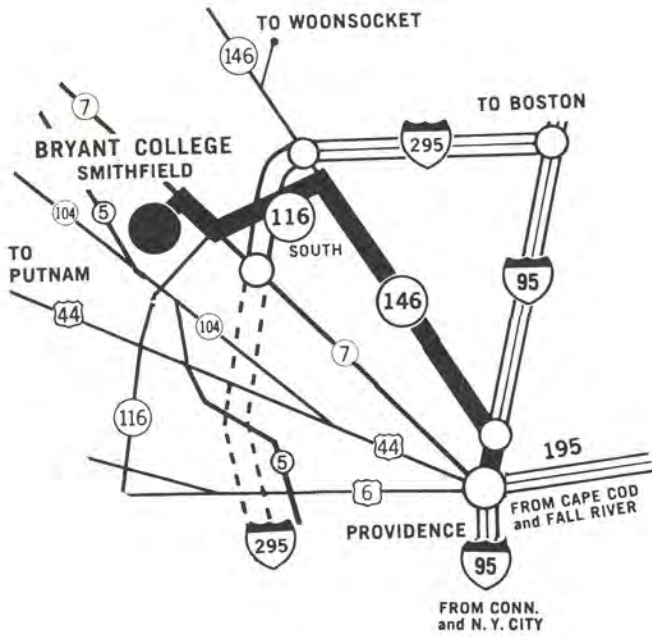
Maybe then we would produce a better world.

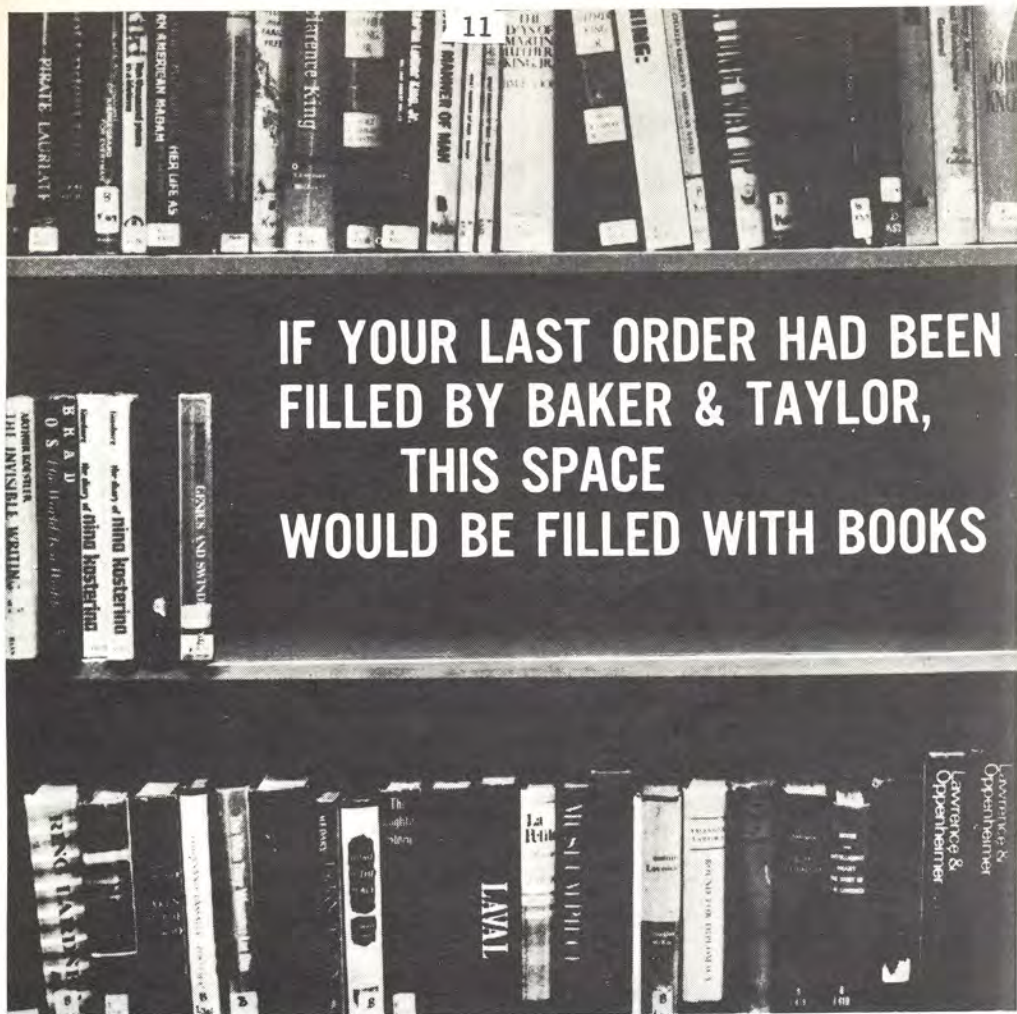
