PRESIDENT'S MESSAGE

Last May the Association adopted a new constitution. For many members this was the culmination of a long struggle to achieve meaningful change in the structure of RILA. Now we are faced with the task of implementing the changes mandated by the new constitution.

The most significant change is in the area of committee structure. Instead of the ten standing committees that existed in the past, we now have three; the Administrative Committee, the Professional Committee, and the Public Affairs Committee. The chairman of each of these committees is a member of the Executive Board. To facilitate the transition from old to new, two

elected members of the Executive Board are serving in the dual capacity of standing committee chairmen and members at large. The third standing Committee chairman was appointed by the board.

This year's Fall Conference is a break with tradition. We have scheduled a two-day conference in order to allow more people to attend, and to provide a more varied program. Newport, with all its attractions, is an ideal setting for a conference of this type.

PUBLIC LIBRARY STANDARDS

The RILA Standards Committee worked diligently during the past year to develop a new set of Standards for Public Libraries in the state. During the month of September, meetings were held in each of the five regions to enable librarians and trustees to express their views on the proposed new standards.

The Executive Board of RILA met on October 11, and reviewed the proposed standards along with the comments and suggestions received at the September meetings. A decision was made to refer the proposed standards back to the committee for reconsideration. Therefore, in view of the time needed for the committee to complete its work, the standards will not be presented to the membership for adoption at the Fall Conference.


A PROPOSED RILA RESOLUTION REGARDING
COPYRIGHT REVISION

The following is a proposed resolution formulated by the ALA Legislation Committee. It will be presented to the membership of RILA for consideration at the Fall Conference. Background information regarding the Williams and Wilkins case may be found in "Williams and Wilkins - The Great Leap Backward," by William North, American Libraries (May, 1972) pp. 528-530.

WHEREAS, the Report in the case of Williams & Wilkins Co. v. The United States, rendered on February 16, 1972 by the Commissioner of the Court of Claims, if accepted by the Court, would effectively limit the capacity of libraries to serve their patrons, would preclude the maximization of the library resources of the country and would require libraries to deprive their patrons of their legal right to the fair use of library materials; and

WHEREAS, the public interest in education and scholarship and the Constitutional rationale for copyright is repudiated by the Report of the Commissioner;

NOW THEREFORE BE IT RESOLVED that the Rhode Island Library Association in annual conference assembled at Newport on November 2, 1972, a) expresses its disagreement with the Commissioner's Report in the Williams & Wilkins case because of its adverse impact on education, scholarship and research; b) requests the United States to seek Supreme Court review of any decision by the Court of Claims which accepts the Commissioner's Report c) urges our Representatives in the Congress to support the current endeavors of the American Library Association to protect the public interest through revision of the copyright law.
