Since 1967 he has served as the director of the West Warwick Public Library System which comprises the Champlin Memorial and the Crompton Free libraries. Under his direction and with his special interest in book selection, the Champlin Memorial Library can boast of an excellent collection for a library of its size. Especially noteworthy is the growing reference collection. He has been active in the continuing fight for intellectual freedom, has done radio work to keep libraries in the public's mind, and has been an active member of R. I. L. A.

Paul is married to the former Catherine Cotter and is the father of two girls and three boys. His home is located in Hope, Rhode Island.

As Paul F. Crane takes on the duties of the presidency of R. I. L. A., we look forward to a year as successful and busy as the one just closing under the leadership of Richard A. Olsen.

3:30-5:30 CHANGE AGENTS, Session 2


Followed by a question and answer period.

CHANGE AGENTS

How well do librarians communicate? Do they reach only the patron who enters the library? Do they get their message to the general public -- the businessman, the student, the hobbyist and the legislator?

Perhaps our communication skills need sharpening, if we are to compete for the tax dollar with more visible community services. The Spring Conference Committee of R. I. L. A. has engaged the services of Change Agents to present a seminar on Communication Skills.

Change Agents is a Connecticut-based counseling and consultant group. They have a team of consultants specializing in services for libraries and librarians. As a central part of their library consultant services, they offer seminars designed to develop communications skills. The training sessions designed to help libraries, library associations, regional systems and individuals use the case study approach.




WHEN IS A STORY MORE
