The library holds substantial monographic and serial publications relevant to this course. There are more than 500 monograph titles returned in a quick search for Autism. We also have a reciprocal borrowing agreement with Brown University that allows faculty and students to visit the Brown Science Library and to borrow materials from Brown both on-site and through Interlibrary Loan.

The allocation for Communicative Disorders for 2015-16 is approximately \$3500.
