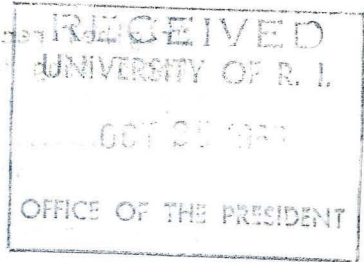

- A. The following dates for the 1967 Summer Session are recommended to replace the present 1967 summer calendar.

Term I

July 4	Independence Day, no classes
July 8 (Saturday)	Regular classes meet
July 25	Last day of classes

Term II

July 27	Classes begin
July 29 (Saturday)	Regular classes meet
Aug. 14	V-J Day, no classes
Aug. 19 (Saturday)	Regular classes meet
Sept. 1	Last day of classes

- B. The present 1967 summer calendar appears as follows in the University Catalog.

Term I

Term II

July 31	Classes begin
