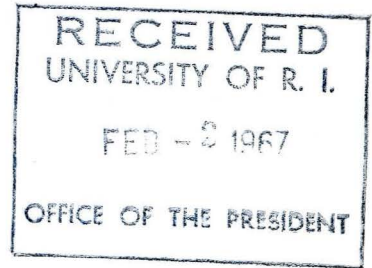

1. The Attached BILL, titled Make-up privileges for Commuter Students on Hazardous Driving Days

I. Charge

Consider the request of the Student Senate for a review of University policy regarding class attendance on days of seriously inclement weather.

II. Recommendation

University Manual page 57, 1.06.4. Change as follows:

Insert, before the last sentence, the following:

"Commuter students shall be entitled to make-up privileges for work missed on days officially declared to be 'hazardous-driving days' by the administrative officer responsible for this decision."

III. Comment

"Hazardous driving days" are determined as follows: Vice President Thornton McClure consults with State Police Headquarters, then he and President F. Horn make the decision. Vice President C. Hall reports their action to the radio stations.
