Dear Senator Pell:

Thank you for your letter in support of Theater by the Sea, which has applied to the National Endowment for the Arts for assistance under the Architecture, Planning and Design Program and the Theatre Program.

I am pleased to inform you that Theater by the Sea's application to the Theatre Program has been recommended for funding by the National Council on the Arts, and is currently undergoing a detailed final review. As soon as this process is completed, we will send your office an official notification.

Theater by the Sea's application to the Architecture Program under the Cultural Facilities Research and Design category was reviewed by the Cultural Facilities Advisory Panel in March. The Panel's recommendations were then brought before the May meeting of the National Council on the Arts. The review process was a long and careful one, involving many difficult decisions, since the volume of worthwhile applications substantially exceeded the amount of funding available for this category. I regret that Theater by the Sea's application was not among those finally recommended for assistance.

The staff of the Architecture Program has been in touch with the Theater by the Sea staff to discuss this decision, and to let them know that the Endowment would welcome another application from Theater by the Sea.
