- C. ANNOUNCEMENTS/CORRESPONDENCE/REPORTS/Updates**
1. The ACLU-URI Student Chapter - Chair updated the Committee about a student voting initiative organized by the ACLU-URI Student Chapter. The group is interested s encouraging faculty to consider accommodations related to Election day at the September meeting of the Faculty Senate. These include adding Election Day as an excused absence similar to holy days and University-sanctioned events (UM 8.51.11-12) or holding no classes on Election Day.

 3. Chair provided an update of the September 17th meeting with the Provost.
- D. UNFINISHED BUSINESS**
1. **ABM** – The matter of the committee(s) to review the ABM framework was revisited. Because the ABM framework affects both undergraduate and graduate students and because an expeditious and thorough review is sought, the FSEC recommends the formation of a six-member special committee as permitted by UM 8.85.12. This committee is charged with reviewing the ABM framework as specified in Appendix K of the Graduate School Manual (<https://web.uri.edu/graduate-manual/appendix-k/>) and making recommendations for change, if necessary. The goal is to have the committee report back to the FSEC expeditiously. Possible committee members were discussed. Chair Hillary will reach out to potential committee members.
