FACULTY SENATE EXECUTIVE COMMITTEE (FSEC) MEETING # 3
June 4, 2019 MINUTES

 - to recommend that the student appointed by the President to the URI Board of Trustees with the with the advice and consent of the Student Senate. *The motion was made and approved.*
 - to recommend that the student appointed by the President to the URI Board of Trustees with the with the advice and consent of the Student Senate be a full voting member. The motion was made and approved.

 - a. Faculty Senate Executive Committee continued discussion of Faculty Senate Standing committee appointments
 - b. Faculty Senate Executive Committee meeting of June 11th is cancelled. Next meeting of the FSEC will be on June 18, 2019 in the Library Conference Room 203.
