**Faculty Senate Executive Committee (FSEC)
Meeting # 18 October 11, 2019 MINUTES**

1. CALL TO ORDER
 - a. The Faculty Senate Executive Committee (FSEC) meeting was called to order at 10:49 AM in the Library Conference Room B by Chair Nassersharif, Vice Chair Echevarria, Senators Barbour, Gindy, and Morokoff were in attendance. Senator Hicks was absent
2. APPROVAL OF MINUTES
