BILL #233

The Faculty Welfare Committee recommends that the Senate request the Administration to direct the Housing Office:

- 1A. To make accommodations for faculty in the Faculty Apartments available on a temporary basis only, and for a maximum of two years.
- B. To limit leases to one academic year if it is necessary to rent apartments to non-faculty.
2. That 1A and 1B become effective upon approval by the President with a maximum rental period of two years given to all occupants.
