Faculty Welfare Committee
Report No. 3, 1968-69
December 19, 1968

The Faculty Welfare Committee recommends that the Office of Institutional Research provide the Welfare Committee with the information necessary to compare fringe benefits at URI with those at comparable institutions.

Comments: Item No. 13 of the Faculty Senate's recommendations and remarks in response to the Peat, Marwick, Mitchell and Co. Report to the Board of Trustees on Faculty Compensation, approved by the Senate on September 29, 1966, recommended "that the Faculty Senate Standing Committee on Faculty Welfare, in cooperation with the Office of Institutional Research, be requested to prepare a list of "other benefits" received by URI faculty, to estimate their cost and monetary value, to attempt to compare them--every two years--with benefits received by faculty members in other comparable institutions, to make recommendations through the Senate and the President to the Board of Trustees."

The Committee prepared a comparison and submitted it to the Senate with its recommendations on March 13, 1968. The Committee now feels that collecting the data necessary to keep this comparison up to date is best performed by the Office of Institutional Research.
