BILL #256

That the Vice President for Academic Affairs establish and serve as chairman of an Ad Hoc Calendar Advisory Committee consisting of two faculty members, and two students with the following charge: (1) To determine specific guidelines for constructing a University calendar based on fixed dates for scheduling all academic events; (2) To determine the feasibility of having the Vice President for Academic Affairs assume the responsibility for the University calendar based on guidelines to be established by the committee; (3) That this committee report its findings back to the Senate no later than November 1969.
