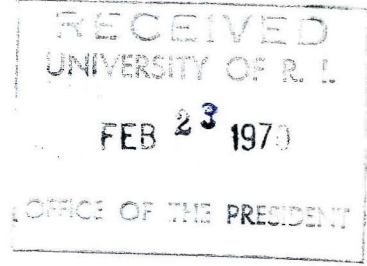

1. That the following statement of General Education Requirements be substituted for the present General Education Curriculum statement on page 15 of the 1969-70 University Catalog.

All undergraduate students in baccalaureate degree programs at the University and in its Division of University Extension are required to select and pass 45 credits of course work from the following three divisions. Of these credits, 18 shall be taken in one division, 15 credits in a second, and 12 credits in a third. Within each division, no more than 2 courses may be taken in one department or subject-matter area for general education credit.

Division A

Any course for which the prerequisites have been met in Art, Music (literature and history), Classics, English, Languages (except 1 and 2), Linguistics and Philosophy. Also: Theatre 1, 82, 83; and Speech 32, 132, 133. Only one studio course in Art may be applied to this requirement.

Division B

Any course for which the prerequisites have been met in Astronomy, Bacteriology, Biochemistry, Biology, Botany, Chemistry, Climatology (Geog. 104), Geology, Genetics, Mathematics, Meteorology (Geog. 103), Oceanography, Physics, Zoology, and Earth Science.

Division C

Any courses for which the prerequisites have been met in Economics, Geography (except 103, 104), History (except 193), Political Economy, Political Science, Psychology (except 10, 70, 110, 120), Sociology and Anthropology. Also: Education 2, 12, 103; Journalism 133, 135, 138; and Speech 27, 114, 117.

Exception

Advanced ROTC students may apply a maximum of six credits of Military Science to the General Education Requirements. No more than three credits may be applied to any one of the three divisions.

2. That the recommended statement of General Education Requirements become effective immediately, and that all undergraduate students currently enrolled in baccalaureate degree programs shall have the choice of shifting to these requirements or remaining with the present General Education Curriculum.
