

To become effective in academic year 1970-71.

- A. Abolish standing Faculty Senate Salary Committee.
- B. Form standing Faculty Senate Compensation Committee with following charge:

The purpose of this committee shall be to provide continuing analysis of and recommendations for faculty compensation at the University of Rhode Island. The committee shall make an annual review of the salary schedule, shall make an annual review of other compensation received in the form of financial benefits, such as insurance and annuity programs, and shall make recommendations to the Faculty Senate concerning all matters of salary and financial benefits.

All written reports of the Compensation Committee shall be distributed to the entire faculty.

- C. Amend charge of Welfare Committee by substituting the following:

The purpose of this committee shall be to consider all such non-academic matters affecting the welfare of the faculty except salary and compensation received in the form of financial benefits, as may be suggested by the committee itself, the General Faculty, the Faculty Senate, or the University administration.

The Chairman of the Welfare Committee, or his representative from that committee, shall also be a member of the Compensation Committee.
