

### "Limiting What Students Shall Read" Is Now ERIC Document

"Limiting What Students Shall Read," the report of a survey of school-book selection practices and pressures, is now entered in the Educational Resources Information Center (ERIC) document clearinghouse system. The American Library Association (ALA) cosponsored the survey with the Association of American Publishers and the Association for Supervision and Curriculum Development.

In addition, the full back-up data assembled during the survey, which was sent to some 7,500 public school administrators and librarians, about 25 percent of whom responded, has also been entered in the ERIC document clearinghouse system.

An abstract of the ERIC documents appeared in the May 1982 issue of Resources in Education, ERIC's abstract journal. Both documents are available in paper or microfiche. The printed report, also available from ALA and the cosponsors, is available through ERIC under ED Number 210771. ERIC charges \$3.65 plus up to \$1.55 UPS shipping charges for this 43-page document.

The full set of back-up data, 92 pages long, is available under ED Number 210772 at \$6.95 plus up to \$1.93 in shipping charges.

## Introduction

For the second year in a row, the RILA Personnel Committee is pleased to report that one hundred percent of the public libraries in the state of Rhode Island responded to the 1982 salary survey. As a result, we will be able to maintain a historical record as well as provide a firm data base from which to spot trends, draw conclusions, and provide you with up-to-date information. It is due to the excellent cooperation of the public library directors that we are able to achieve this important goal along with the Department of State Library Services (DSLS), which deserves equal praise.

The economic health of the profession in Rhode Island is a topic of major concern for us all. Timely reporting of the salary picture is an important facet of the charge of the Personnel Committee. Thus, we will no longer wait until we have comparative statistics from any of our neighbors. While that may tend to weaken the report, it will be offset by our early reporting of the data so that those libraries involved in budget considerations for the coming fiscal year can use the latest statistics. As statistics from other states become available, we hope to publish them as supplements to the main committee report. The updates of these statistics will appear in future issues of the RILA Bulletin.

## Preliminaries

There have been no deviations in the collection procedures from last year. DSLS collected the data as part of its statistical gathering process. The questionnaires were then sent to the University of Rhode Island Graduate Library School where the cover sheets were removed and each library received a random number. This procedure insured anonymity of response. Ms. Lynne Kaplowitz assembled the tables by abstracting the information from the questionnaire. The tables were then turned over to the RILA Personnel Committee which acted as initiator and coordinator of the salary survey. The co-authors of the committee report were appointed as a sub-committee of the main committee and conducted the analysis.

## The Survey

The salary survey questionnaire was sent out to forty-four public libraries during the summer of 1982. Table 1 shows the distribution, by population, of the public libraries in Rhode Island.

As the table shows, there was a one hundred percent response. It also shows that there were no changes in the status of the libraries over the past year. Given the state of the economy, it is encouraging that no communities in the state suffered the total loss of library services.

### Interpretation

Some preliminary statements must be made that will enable you to see how the analysis was made and to understand the limits of the report. The first is comparability with the 1981 survey. Table 1 shows us that neither the number of libraries who have reported has changed, nor has their status regarding population. Thus, the statistics reported here are directly comparable with the 1981 survey. This is a result of having the same response rate (100%) for both of the surveys. For your information, Table 6 shows the salary ranges for selected groups for the state of Massachusetts in the 25,000+ population category. This data is the same as that reported in Table 7 in the 1981 survey. We report it for information purposes recognizing that the figures are not directly applicable. Comparability with Massachusetts remains unchanged. We refer to the 1981 report (RILA Bulletin, October, 1982) for a full discussion of this issue.

### Analysis

For the salary ranges, each table is divided into categories of jobs by population size with the lowest reported salary, median or mid-point of the range, mean or average salary (a new addition to the analysis), and the highest reported salary. The figures for 1981 and 1982 are included. Note: These are not new figures, but are from the 1981 salary survey in Massachusetts. Anytime salary figures are unavailable, there is a line (-----).

Table 2 shows the salary ranges for less than 5,000 population. Since the start of the survey, this has been the grouping with the lowest salaries, but it also represents the greatest progress in salary improvements. This year is no exception. The Library Director position shows an increase of \$1,000 over last year. This is approximately a nine percent gain over last year. When compared with the top salary of the Library Director in the 5,000-9,999 (Table 3) category, there is a \$3,320 difference. However, the top salary for the less than 5,000 population group is \$1,625 more than the low reported salary in the 5,000-9,999 category. When compared to the mean or average salary of this category, the top salary of the Library Director in the less than 5,000 population is \$898 less. Similarly, it is \$1,000 less than the median salary. The low salary of the population grouping 10,000-24,999 (Table 4) is still comparable at \$300 more than the salary for the less than 5,000 Library Director. Table 2 reports a major change in the part-time wage for Library Director. A change of hourly wage of \$4.53, to say the least, is considerable. Less dramatic, but nonetheless significant, is the increase in the median part-time wage by 75 cents and 42 cents for the low end of the range. The Assistant Director showed a gain of 60 cents per hour at the high end which also represents a respectable increase in wages. A glance at the rest of the chart indicates improvement in other categories with the exception of Pages. Here, the wage remains the same. One can conclude from the figures that many of the disparities that have been reported in previous surveys are disappearing. Librarians in this category are doing better than the recent past. The Library Director salary is \$1,980 more than what was reported in 1980 with part-time figures up from the \$4.00 per hour at the low salary level in the same year. This trend should also encourage those who do not have an MLS to pursue one. For the first time since the start of data collecting, this is recommended.

The eight libraries in the 5,000-9,999 population grouping are represented in Table 3. Full-time Library Director salaries are up \$1,320 from the last survey. At the low end of the scale, there is an \$875 raise. This represents increases of approximately nine percent at both ends of the range. The Library Director high salary is up \$2,820 from 1980, and the low is up \$5,150. Beginning salaries in this population category have shown a sizeable improvement, but a word of caution is necessary. The 1980 survey did not include all of the libraries in the state. Thus, as a result, there may be some distortion of the figures. There is little doubt that the starting salaries have made improvements regardless of the criteria used. As the table indicates, there are still part-time directors in this population category. The low end shows an increase of 90 cents per hour with the mean salary at \$5.82 per hour. No change is reported for the high, part-time salary. One should note that the Staff Librarian is receiving \$1.35 more than the Assistant Director at the high end of the reported figures. Still disturbing are the wage differences between custodial and other staff positions. The custodial staff is receiving 40 cents per hour more than those at the Library Associate/Senior Library Technician staff. The high Library Technician wage is also more than the Library Associate/Senior Library Technician. This may be due to problems of definition rather than to actual differences, but this is what the figures show. In addition, the Library Director receives \$1.80 more per hour than the custodian in the average or mean compensation category. Some categories are doing better, but some are also marginal when the comparison is made. Comparisons of professional staff and custodial staff are not meant as a criticism of the custodial staff. On the contrary, we all know how important their job is and how much we rely on them to help maintain the library. However, given the amount of education necessary for becoming a professional librarian, there is room for vast improvement for the hourly salaries of professionals.

When you compare the Library Directors in less than 5,000 (Table 2), 5,000-9,999 (Table 3), and 10,000-24,999 (Table 4) populations, there are some interesting results. The Library Director of the less than 5,000 population is higher than the low salary reported for 5,000-9,999 by \$1,625, but it remains lower than either the mean or median salaries. The high salary for the Library Director in the 5,000-9,999 range is \$1,897 less than the high for the Staff Librarian in the 10,000-24,999 grouping. However, the mean salary for the Library Director is higher by \$805 for the Assistant Director, \$148 for the Staff Librarian, and \$737 less than the Branch Librarian.

Compared to 1980, the Library Director has received an increase of \$2,820 at the high end and \$5,150 at the low end of the scale for those who reported in that survey.

The salary ranges for the 10,000-24,999 population are shown in Table 4. For Library Director, there is an increase of \$2,200 at the top of the range. The median is up by \$1,195, and the low shows a gain of \$1,300. There is still a large gap between those who work in this job category and those who work in the 25,000+ population grouping. In Rhode Island, the break point in salary differences is considerable between these two population categories. When compared to the 25,000+ ranges, there is a \$6,200 difference at the low end of the range, \$6,684 at the mean, \$4,189 at the median, and \$11,465 at the top of the range. While this may be true for Library Directors, one cannot categorically state that salaries are better at the 25,000+ category at all levels. The Staff Librarian is virtually the same at the high end of the range as well as at the median and mean levels. The low end of the range shows that this category is better than the 25,000+ by \$956. Senior Librarians start at approximately the same level (\$14,917 vs. \$14,732), but the differences increase dramatically as the full extent of the range is considered. At the top there is a \$6,916 difference in favor of the 25,000+ group. Branch Librarians make more (\$1,602) than their counterparts at the 25,000+ level, but, again, the top of the range shows a major difference of \$6,077. Library Associates and Senior Library Technicians are roughly comparable at the low end of the range, are close in the mean salary range, and are separated by approximately \$1,000 at the high end. The Library Technician, on the other hand, starts at \$2,165 more than the same position in the 25,000+ population grouping. This job category is generally a bit better in the 10,000-24,999 range and is \$645 more than the highest in the 25,000+ job. For clerical positions, those in the 10,000-24,999 category are better paid than their counterparts in the 25,000+ population. They make \$1,268 more at the low level. Mean and median salaries are comparable, and the top salary is \$3,024 in favor of the 10,000-24,999 level clerks. The high salary of the clerical staff is higher than either category of Library Technicians. It is higher than the starting salary of Staff Librarians by \$5,518, and \$2,397 more than the Branch Librarian. It is only at the high level that the Staff Librarian makes more, with the Branch Librarian making \$479 less at the high end of the range. The custodians show the same strength relative to the rest of the staff as mentioned previously. Finally, the part-time Library Director category makes a lower hourly wage (\$1.87 less) than a counterpart in the less than 5,000 population group.

The 25,000+ population grouping is shown in Table 5. When these salaries were reported at the annual RILA meeting in November, there was some discussion of the high salaries in the Library Director, Assistant Director, Senior Librarian, Staff Librarian, and Branch Librarian categories. A recheck of the reported figures indicates that what was first reported is accurate. There is no change in the high salary for the above-listed positions. No salary increases were reported in the 1982 survey. This is the first time since the inception of the survey, that full-time salaries have remained the same. It reflects the financial difficulties that many find themselves in and is cause for great concern. Given the rest of the table, there is some encouragement because there is obvious upward movement in the salary structure for many of the other categories. While the top of the range for Library Director stayed the same, the low salary moved up \$3,200 or approximately twenty percent. The low salary for Assistant Director increased by \$2,932. Senior Librarian increased by \$1,700, and Branch Librarian by \$556. Decreases were recorded for the Staff Librarian (\$1,176), Library Associate/Senior Library Technician (\$813), Library Technician (\$1,805), and Clerical (\$1,805). Median salaries also decreased for the Staff Librarian, Branch Librarian, and Library Technician. It is still disturbing that this population grouping could have a part-time Library Director category. The wage reported is smaller than that of the less than 5,000 (by \$5.40), 5,000-9,999 (by \$2.60), and 10,000-24,999 (by \$3.53) population groups.

The static salary picture in some parts of Table 5 may be the forerunner of problems for the rest of the profession in the state. Lower starting salaries are probably due to the shortage of jobs and the surplus of qualified people who are willing to take less. Static salaries at high levels are not as much of a problem for those concerned as lower starting salaries for those who are beginning professionals. But there is a definite danger that top people in the state will look elsewhere, a situation that no one wants to see happen. We need very highly qualified people at all levels to get the libraries in the state through these difficult times. No matter where the status quo or the cuts occur, the end result is not good for Rhode Island libraries. It is hoped that this is a temporary condition.

Table 6 is a duplication of the Massachusetts Salary Ranges for their 1981 survey. It is for your reference as you compare the salaries for the 25,000+ population in Rhode Island. The 1982 survey was not available, and the communities decided not to wait in order to get you the results of the Rhode Island survey. Thus, the salaries reported in Table 6 are one year old and should be treated as such as you do your own analysis.

Table 7 reports the various types of fringe benefits available in Rhode Island. Not all surveyed reported on fringe benefits. The figures in parentheses show those reported in the 1981 survey. Increases in fringe benefits occurred with Military Leave, and Personal Leave. Everywhere else there was a decrease in the libraries giving fringe benefits under the various categories. When you look at the unpaid category, the picture is less encouraging. There were no increases in the number of libraries which provided unpaid benefits and only two types of benefits (Bereavement Leave and Medical Insurance) stayed the same. All the rest showed decreases. The one bright spot on the table is Sick Leave. In both full-time and part-time pay for sick leave, there were increases. From this chart, one can infer that cost savings are being realized through a cut in fringe benefits. A reduction in fringe benefits should be of concern, not only because it decreases overall benefits, but because it can create morale problems as well. In addition, a cut in fringes might inhibit participation in the Rhode Island Library Association.

Table 8 shows the Vacation Leave for employees of Rhode Island Libraries. Regardless of type of employee, professional or non-professional, the majority receive six-fifteen days of vacation each year. Professional librarians are not rewarded significantly better than non-professionals when it comes to vacations. There seems to be little change over last year.

### Conclusions and Recommendations

When you look back at the tables, it is obvious that we have fared relatively well during the past year. While there are some danger signs in a couple of areas, overall the picture is not that discouraging. The trends identified have to be closely watched, and the Association must be prepared to take action if there is any serious deterioration in the salary and fringe benefits structure. Hard economic times mean reductions, and this cannot be helped. This does not mean that we should be complacent. We should take stock of how we prepare our budgets and present them to funding authorities so that we can do a better job in the budget process.

At the 1982 Annual Convention, the Rhode Island Library Association adopted a minimum \$13,000 starting salary. A quick glance at the table will tell you that, of the salaries reported, the following do not meet the minimum as called for by RILA:

Two of the five positions listed are closed or relatively close to the desired minimum. The other three have a way to go. Priority should be set on raising these starting salaries to the \$13,000 minimum set by the Association.

The RILA Personnel Committee recommends continuation of the annual salary survey with the cooperation of DSLS and URI/GLS. When the Massachusetts Survey is released, it should be distributed to the membership for comparison purposes with the 1982 RILA Salary Survey.

THE RHODE ISLAND LIBRARY ASSOCIATION CONSTITUTION  
REVISION ADOPTED NOVEMBER 1981

ARTICLE I. NAME

This organization shall be called "The Rhode Island Library Association".

ARTICLE II. OBJECTIVE

The objective of the Association shall be to promote library and information services in the State of Rhode Island and to encourage interest in libraries, information centers, and librarianship.

ARTICLE III. MEMBERS

Section 1. The membership shall consist of Active, Institutional, Honorary, Life, and Affiliate members.

A. Active member: Any person currently engaged in library and information work or formerly engaged in library and information work, or any member (past or present) of a library and information center, governing or advisory body, or any student in or graduate of a school of library and information science, may become an Active member upon payment of dues as provided in Article VIII and shall have the right to vote and to hold office.

B. Institutional member: Any institution or library active in library and information service may become a member upon payment of dues as provided in Article VIII. An institutional member shall not have the right to vote.

C. Honorary member: Any individual nominated by the Executive Board and selected by the membership shall be an honorary member for a specified period of time to be determined by the Executive Board. An honorary member shall enjoy all the privileges of an active member except the right to vote and to hold office, and shall be exempt from the payment of dues.

D. Life member: Any individual who has been a life member before October 20, 1966, shall continue to enjoy all the privileges of an active member, and shall be exempt from the payment of dues.

E. Affiliate member: Any person, firm, or institution interested in library and information work, and not eligible under A or B above, may become an affiliate member upon payment of dues as provided in Article VIII, and is entitled to all the privileges of the Association except the right to vote and to hold office.

ARTICLE IV. OFFICERS AND EXECUTIVE BOARD

Section 1. The officers of the Association shall be the President, Vice-President/President Elect, Treasurer and Secretary. The duties of the officers shall be those which usually pertain to their offices.

Section 2. Executive Board

A. The Executive Board shall consist of the officers of the Association, the immediate Past-President, the ALA Councilor, the NELA Councilor,

and the Member at Large. Members of the Executive Board shall serve until their successors are announced at the end of the annual business meeting.

- B. The Executive Board may employ staff to carry out the purposes, policies, and programs of the Association.
- C. The Executive Board shall meet at least ten (10) times each year at the call of the President.

#### ARTICLE V. NOMINATIONS AND ELECTIONS

##### Section 1. Nominations.

- A. The Nominating Committee shall submit annually two (2) candidates for each of the offices of Vice-President/President Elect, Secretary, Treasurer and Executive Board Member at Large. Every other year the Nominating Committee shall submit two (2) candidates for the office of New England Library Association Councilor. Every fourth year the Nominating Committee shall submit two (2) candidates for the office of American Library Association Councilor.
- B. Nominees must be members in good standing.
- C. An individual may be nominated for re-election, but may serve no more than three (3) full terms per office.

##### Section 2. Election Procedures.

- A. Election shall be by mail ballot, and a majority vote shall elect.
- B. Each active and life member shall receive a ballot four (4) weeks prior to the annual meeting.
- C. Ballots shall be returned two (2) weeks prior to the annual meeting.
- D. The newly elected officers shall take office at the close of the annual meeting.

##### Section 3. Vacancies.

- A. The Executive Board shall fill vacant offices by a majority vote using a secret ballot.
- B. The Vice-President shall complete the unexpired term of the President in case of a vacancy in that office. If the Vice-President is unable to serve in this capacity, the Nominating Committee shall present names of candidates to the Executive Board, who shall elect a President to serve for the duration of the term of office.
- C. For other vacancies in elective office the Nominating Committee shall present names of candidates to the Executive Board, who shall elect officers to serve for the duration of the term except when the unexpired term exceeds one year. In that case, the person elected will serve to the close of the next annual meeting and the election procedures in Article V, Sections 1 and 2 shall be followed.

## ARTICLE VI. MEETINGS

Section 1. The Association shall hold an annual meeting.

Section 2. Ten (10) percent of the members eligible to vote shall constitute a quorum for the transaction of business at an Association meeting.

Section 3. Meetings shall be conducted according to Robert's Rules of Order (current edition). A parliamentarian shall be appointed by the President for all business meetings.

## ARTICLE VII. RIGHT OF PETITION

Section 1. Voting at the Annual Meeting.

- A. The membership of the Association may petition the Executive Board to place an item of business before the membership at the annual meeting. This petition must have twenty (20) signatures of voting members of the Association and be presented to the Executive Board at least sixty (60) days before the annual meeting.
- B. The text of a petition and the signatories of the petition shall be published in the RILA Bulletin or mailed to the membership prior to the annual meeting.
- C. For a petition to succeed a simple majority shall be required, provided that at least ten (10) percent of the eligible members vote.

Section 2. Voting by Mail.

- A. The membership of the Association may petition of the Executive Board to place on a mail ballot an item of business for a vote of the entire membership. This petition must have twenty (20) signatures of voting members of the Association and be presented to the Executive Board at least sixty (60) days before the mail vote. The Executive Board will conduct the balloting.
- B. The text of the petition and the signatories of the petition shall be included in the mailing.
- C. For a petition to succeed a simple majority shall be required, provided that at least ten (10) percent of the eligible members vote.

## ARTICLE VIII. DUES AND FINANCES

Section 1. Dues shall be due and payable in July of each year and delinquent in September. If dues are not received in September, the privileges of membership shall be forfeited.

Section 2. Changes in Dues Structure

- A. Changes in the dues structure shall be recommended by the Executive Board for approval by the membership at the annual meeting or by mail ballot.
- B. Proposed changes in the dues structure will be published in the RILA Bulletin prior to the annual meeting or included in a mail ballot.

- C. A two-thirds majority vote shall be required in order to change the dues structure, provided that at least ten (10) percent of eligible members vote.

Section 3. The fiscal year of the Association shall begin July 1 and end June 30 of the successive year.

#### ARTICLE IX. COMMITTEES

Section 1. The President, in consultation with the Executive Board, shall appoint standing and other committees and designate the chair of each committee.

Section 2. Standing Committees.

- A. The following shall constitute the standing committees of the Association: Conference, Membership, Nominating, and Publications.
- B. The President, in consultation with the Executive Board, shall provide an annual written statement delineating the responsibilities of each standing committee.

Section 3. The President, in consultation with the Executive Board, shall appoint, designate the chair, and fix the charge of other committees as needed to conduct the business and carry out the purpose of the Association.

Section 4. In order to ensure good communication among its members no committee shall exceed ten (10) members unless approved by the Executive Board. The Committee chair has the autonomy to select the members and to determine the size of the committee. An attempt shall be made to have committee composition be representative of the Association membership.

Section 5. Appointments to committees shall be for two (2) years unless otherwise specified by the Executive Board. No member may serve more than four (4) consecutive years on the same committee.

Section 6. Committee Chairs.

- A. Each committee chair shall submit minutes of the committee's meetings to the President and/or another designated officer. Each chair shall also submit a written annual report to the Executive Board.
- B. Committee chairs may participate in Executive Board meetings but shall not have the right to vote.

Section 7. The President and Vice-President are ex-officio members of all committees, but do not have the right to vote in committees.

#### ARTICLE X. ROUND TABLES

Section 1. The Executive Board may authorize the organization as a round table or assimilate as a round table an existing group of not less than 20 members of the Association who are interested in the same field of librarianship not within the scope of any committee upon the petition by such a group.

Section 2. Round tables may elect officers, charge annual dues and limit their membership. Any member of the Association may become a member of any round table by complying with the requirements of membership.

Section 3. The Executive Board may discontinue a round table when in the opinion of the Executive Board the usefulness of that round table has ceased or upon the recommendation of the round table itself.

#### ARTICLE XI. AFFILIATION WITH OTHER ASSOCIATIONS

Section 1. Affiliation with other associations may be made by a vote of the majority of the members present at an annual business meeting of the Association, provided that notice of the proposed affiliation and an explanation of the affiliation be distributed to the membership thirty (30) days prior to the meeting.

#### ARTICLE XII. COUNCILORS

Section 1. ALA. The Rhode Island Library Association is a chapter of the American Library Association and is entitled to one councilor. The Councilor shall be elected by members of the Association who are also members of the American Library Association and shall serve for four (4) years, or until his/her successor is elected and qualified and shall automatically serve as a member of the Executive Board.


Section 2. NELA. The Rhode Island Library Association is a chapter of the New England Library Association and is entitled to one councilor. The Councilor shall be elected by the Association and shall serve for two (2) years, or until his/her successor is elected and qualified and shall automatically serve as a member of the Executive Board.

#### ARTICLE XIII. PARLIAMENTARY AUTHORITY

The rules contained in the current edition of Robert's Rules of Order shall govern the Association in all cases to which they are applicable and in which they are not inconsistent with this constitution.

#### ARTICLE XIV. AMENDMENTS

The constitution may be amended at any business meeting of the Association by a two-thirds (2/3) vote of the members present and voting, provided that the proposed amendment has been submitted to the membership at least thirty (30) days prior to the meeting.

Rhode Island was noticeable at this Midwinter Conference in San Antonio in several ways:

- 1) Senator Pell was unanimously endorsed by the Executive Board and Council for Honorary membership in the Association; an honor to him, to librarianship, and to Rhode Island. He will accept this honor at the Annual Conference in Los Angeles. We hope to fete him locally, and to publish the recommending and supporting documents in the Bulletin.
- 2) As directed by the RILA Executive Board, I presented Rhode Island's Minimum Salary Resolution to all other Chapter Councilors. Each representative interested in developing a similar effort in his/her state was invited to contact me or the RILA Personnel Committee for further information. Massachusetts Councilor, Margo Crist, also offered assistance. Massachusetts and Rhode Island are the two states to date which have adopted a minimum salary policy. Because it was too late to formally place this issue on the Chapter Conclave agenda, it will be introduced again at the Annual Conference with adequate time for discussion.
- 3) For the first time in memory, Rhode Island donated \$100 to the Washington Office to assist in its efforts toward legislation and funding for libraries. Many states do this regularly, using funds budgeted from their state associations' coffers. Rhode Island's contribution came from individual donations, which was duly noted when the contribution was announced at a Council session.
- 4) I attended a variety of sessions where the new OPM Standards, deprofessionalizing federal librarians were discussed, and where strategies were developed. This will be discussed further later in this report. I was able to introduce an amendment, endorsed by the Feminist Task Force, the Chapter Conclave, and the Council Caucus. The amendment was to a combination of resolutions. It requires that ALA give immediate priority attention to this issue, explore legal options, and report currently and continuously to the profession, which American Libraries and other professional journals have not done. The amendment also calls for a report to Council in Los Angeles.

\*\*\*\*\*

The three major concerns of this Midwinter Conference were: 1) the fiscal difficulties of ALA; 2) a membership dues increase; 3) the OPM issue.

FINANCES: In its effort to wrestle with a deficit that has grown from \$178,000 to \$205,000 since June, the Executive Board agreed to withdraw \$95,000 from the Association's endowment. The Executive Board initiated, however, a schedule for repayment and for restrictions on further withdrawals. Council concurred.

DUES INCREASE: Anticipating objections to considering a membership dues increase at a conference at which the general membership was not represented, and before an increase could be widely discussed and debated, the Committee on Planning and Evaluation (COPES) table the issue.

OPM: Three resolutions were adopted. They will be coordinated/combined into a single statement by ALA staff. They were: 1) That ALA communicate with Congress and appropriate Federal agencies on the Standards, and explore legal recourses (N.J. Library Association). 2) Requesting withdrawal of the proposed Standards in order to conduct a new fact-finding effort, this time performed by a "full-partners" team of very wide representation (Committee on Legislation and the Federal Librarians' Round Table). 3) A general combination of the preceding points (PLA Board of Directors). All three resolutions were adopted as amended by Rhode Island. (Please see above.) We learned at the Conference that the Government Accounting Office (GAO) has been called in to review OPM's Standards. It will be important that this report be made available to ALA, and be widely publicized.

It was rewarding that this particularly immediate and vital issue was finally getting the wide attention it has been without, and that fiscal implications were not deemed a reason not to proceed. California, New Jersey, and Rhode Island were cited as states that have rallied in protest. All other states were given an "activity" sheet to use for further action.

### RILA EXECUTIVE BOARD

At the meeting of November 30, the Board set its operating procedures for the year.

The Board decided to write a letter to Rhode Island's Congress people to request that hearings on pay equity, as it applies to the proposed standards for federal library and information service workers, be re-opened. The letter was requested by the District of Columbia Library Association. The Board also approved the idea of enlisting the Coalition of Library Advocates to write letters in this regard.

President Howard Boksenbaum reported that the total volume of sales of library logo materials at the Annual Conference was \$635 (\$527 in sales and \$108 in orders). RILA should realize \$162.50 on these sales.

President Howard Boksenbaum was charged with the responsibility of appointing an editor for the Legislative Newsletter who will be paid \$500 to produce two issues per month during the General Assembly session (January to May).

The Board approved a press release on the availability of RILA's IFC Handbook.

The Board unanimously approved re-affiliating itself with RI/Junior Members Round Table for another year.

The Board recommended that Howard Boksenbaum inform public library boards and public library directors, by letter, of RILA's new policy regarding minimum salary and the advertisement of library positions.

The Board approved by consensus a proposal to be submitted by Jane Lemos to the Grolier Association for RILA bumper stickers.

Existing RILA special committees were reconfirmed for this year by consensus. Three new special committees were confirmed by the Board for this year: New Technologies, Financial Planning, Trustee Affairs. Chairpersons of RILA Committees for this year approved by the Executive Board are: Conference - Regina Slezak; Membership - Paul Drake; Publications - Debbie Barchi; Government Relations - Beth Perry; Intellectual Freedom - Melody Brown and Bill Bergeron; Personnel - Florence Doksansky; Public Relations - Jane Lemos; New Technologies - Jean Nash; Trustee Affairs - Connie Lachowicz.

# BULLETIN BOARD

**FUND DRIVE:** Providence Public Library is conducting its annual fund drive during December and January in hopes of raising \$100,000. To mark the start of the drive Governor Garrahy proclaimed Monday, November 30, 1982 as Providence Public Library Day in Rhode Island. The governor urged all Rhode Islanders to support the "Challenge '83 Your Chance to Make the Difference" fund appeal. Mayor Vincent Cianci proclaimed December and January as Providence Public Library months, noting the high quality of service that the library has provided to residents and businesses for more than 100 years.

**CHAMPLIN GRANT TO PPL:** The Champlin Foundation recently granted almost \$340,000 to Providence Public Library for a multi-processor system. The new technology is a second computer system that will operate together with its present system. The combined system will increase the speed of computer transactions, quadruple the present system's capacity for storing information, and provide a back-up system in case the first computer stops working. The system will enable other libraries in Rhode Island to interconnect for on-line access to automated services, such as purchasing, cataloging and circulation, as well as giving the public direct access to automated catalogs in all member libraries.

**VACUUM FUMIGATOR READY:** The John Hay Library at Brown University has announced that its vacuum fumigator is now in operation and is available on a cost-plus-labor basis. For further information, call Roberta Sautter at John Hay, 863-1502.

**ORIENTATIONS HELD:** The Western System Office recently conducted two orientations to familiarize librarians and their staffs with the staff and workings of the System Office at the Warwick Public Library.

**CRANSTON WINS MAGAZINE INDEX:** The Cranston Public Library won a second place drawing from an exhibitor at the June ALA Conference in Philadelphia. The prize was a free three-month subscription to the Magazine Index--a microfilm periodical index. The equipment has been placed at the William Hall Library for the three month period.

**OPEN HOUSE:** Tyler Free Library is conducting an open house on January 16, 1983 to show off the recently completed interior renovation. The library is situated in southern Foster. Author James Houston is the featured speaker of the afternoon.

**COVENTRY NEWSLETTER:** Director Virginia Carter and her staff at the Coventry Public Library began publishing a newsletter this past fall. Entitled "What's Going On", the newsletter keeps patrons aware of library happenings.

**STAFF EXCHANGE:** The Coordinators of the five system offices in the state have established a policy of staff exchanges to familiarize the staff of their offices with the workings of each other. They are hoping that this staff exchange will lead to better understanding and better communication among the system offices.

**KWANZA FESTIVITIES:** The 10th anniversary celebrating Black heritage held recently at Providence Public Library South Providence Branch featured an expansion of the traditional African Harvest festival, Kwanza, to include adult participants as well as children. Adults read poetry, the Lion I Band performed, and African experts spoke about Kwanza from two perspectives. The children dramatized the seven principals of the harvest festival. The celebration was made possible by funding from the Mayor's Office of Community Development.
