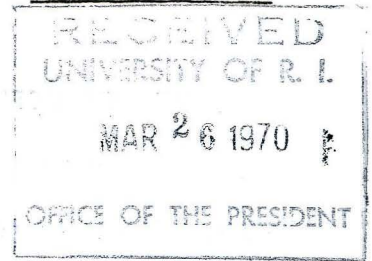

Amend Section 8.40.10, page 65, 9th Edition, University Manual to read as follows (changes and additions underlined):

8.40.10 Curricular Requirements. In any curriculum the minimum number of credits required for graduation shall be 120 and the maximum 148 for a four-year program. Every curriculum shall include at least 6 credits of free electives. No curriculum shall exceed 32 classroom and laboratory contact hours per week in any one semester.
