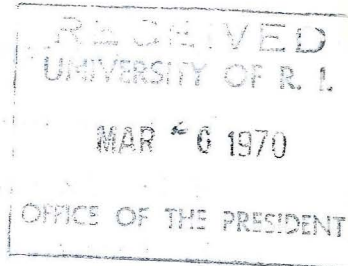

If the bill is forwarded to the Board of Trustees, it will not become effective until approved by the Board.
