The Library Impact Statement for BUS 224G *The Social, Economic and Political Dimensions of Real Estate Development* states that students will <u>not</u> be conducting library research in the course, and the proposed syllabus confirms this. The responses are "None" to the prompts on the Course Request LIS Form, "LIST the critical journals, monographs, and electronic resources in the field that the University Library MUST have in order to support this course or program" and "LIST any additional journals, monographs and electronic resources in the field that would support the course, but are NOT essential." Course readings and case studies will be provided by the instructors. Students completing the two written assignments in the class, which will compose 60% of their grades, may benefit by consulting general news and periodical sources available through the URI Libraries, depending on their assigned topic (e.g. an assignment on the site selection of the Amazon H2Q). Here are the main URI Libraries resources that might be helpful in this regard:

- US Major Dailies (for national newspapers)
- ABI/INFORM Complete (for articles from the business press)
- Academic Search Complete (for general and scholarly articles)

The total annual cost of the resources listed above is \$75,426.46. An additional \$40,530 a year is available for the *one-time* purchase of information resources through library funds allocated for the College of Business and from the Independent Insurance Agents library endowment.

Based on my review of the Library Impact Statement and the proposed syllabus for BUS 224G *The Social, Economic and Political Dimensions of Real Estate Development*, I conclude that:

Students will not require information skills education from the library for this course.

Existing library resources are suitable; no new library resources or funds are required to support the course.

In my role as Subject Selector for the College of Business, I support the addition of this course.
