The term of the Chairman of the Curricular Affairs Committee shall be two years and the Curricular Affairs Committee shall have a vice Chairman appointed by the chairman of the Faculty Senate.

Change University Manual as follows:

Renumber Section 5.75.13 to 5.75.13a.

Add Section 5.75.13b -- The term of the Chairman shall be two years.

Add Section 5.75.13c -- The Chairman of the Faculty Senate shall appoint from among the members of the Curricular Affairs Committee a vice chairman who shall perform the duties of the committee chairman when that chairman is unable to act.

Amend Section 5.75.12 as follows (changes underlined):

The committee members, its chairman, and its vice chairman shall be chosen by the chairman of the Senate and confirmed by the Senate --- (line 9, item 5.75.12)
