Delete Sections 8.10.11 and 8.10.12 of the University Manual and replace with wording in 8th Edition of Manual as follows:

8.10.11

Grade Symbols. Student grades shall be reported as A, B, C, D, F. These marks shall indicate the following standing:

- A -- superior
- B -- good, above average but not superior
- C -- average
- D -- low grade, below average, passing
- F -- failure

8.10.12

Quality Points. Grades shall be given quality point values as follows:

- A -- 4 points
- B -- 3 points
- C -- 2 points
- D -- 1 point
- F -- 0 points
