Amend Section 7.10.11 of the University Manual, 9th Edition, page 40, by substituting the following:

7.10.11 Those members of the faculty who retire and have reached the rank of Associate Professor or Professor and have served the University a minimum of ten years immediately prior to retirement shall be granted emeritus status. Members of the administration with the title Dean, Provost, Vice President, President and Librarian who have served the University ten years in that capacity immediately prior to retirement shall be granted emeritus status.
