Change Section 8.45.10 of the University Manual, 9th Edition, page 67 to read as follows:

8.45.10 Each faculty member has a responsibility and authority for determining class attendance requirements. These requirements shall be announced at the beginning of the semester. Any deviation from announced policy shall be a matter between instructor and students. When a student finds that he will or has been unable to fulfill any obligation he should initiate being excused from that obligation and arrange plans with the instructor for making up the work missed. This regulation applies to any student regardless of his status.
