Moved that the Faculty Senate call upon the Student Senate and the Graduate Student Association and join with the latter two in the conduct of individual advisory referenda to determine the views of both the faculty and the students of the University, concerning the feasibility of having a moratorium on classes for the period of October 26, 1970, through November 3, 1970, so as to permit students to gain firsthand experience with the electoral process and with the understanding that this moratorium will not shorten the academic semester.

It is proposed that the referenda offer two options:

OPTION A. Operate the University according to the calendar as printed in the current catalog with the correction that Veteran's Day will not be on October 26 but rather on November 11.

OPTION B. Modify the Fall semester calendar as follows:
